Part III items 2 and 3. The organization began operations on Oct 1, 2019. No prior Form 990 exists, all activities are new services to this organization. **Part III item 4a – (Estimated Expenses \$ 45,000 cash plus donated time value of \$80,000) (Revenue \$ 112,500)** The California Access to Justice Commission ("CalATJ") provided services to the State Bar of California in support of its access to justice agenda. The services were deliverables compensated by an annual fee pursuant to a Services Contract.

1. CalATJ, with the assistance of the Legal Aid Association of California (LAAC), an online tool entitled the Justice Map, calatj.org/justice-map The Justice Map is an online app capable, on an ongoing basis, of identifying the types of legal services available for low and moderate-income persons throughout the State of California. CalATJ and LAAC completed an initial version of the Justice Map before June 30, 2020. The Justice Map includes case type (e.g. family law, consumer debt) and level of service (e.g. self-help, form packets, representation) for court-based services and services provided by legal service providers and pro bono attorneys working with those providers.

2. Report Regarding the State Bar Strategic Plan. CalATJ provided the State Bar with written recommendations and advice regarding specific objectives that could be added to the 2017-22 State Bar Strategic Plan for the 2020 calendar year to further the State Bar's goal of supporting access to justice for all California residents and improvements to the state's justice system. The Board of Trustees of the State Bar relied on CalATJ's recommendations in adding two objectives to its Strategic Plan.

3. Justice Gap Study. The State Bar of California determined that "National studies and related statistics have pointed to a significant justice gap, defined as the gap between civil legal needs and available resources. No comprehensive study of the justice gap in California, the largest state in the nation, had ever been done." The State Bar conducted a survey of nearly 4,000 Californians on the civil legal problems they faced; an Intake Census of legal aid organizations about their ability to serve those who requested legal help; an analysis by LAAC of workforce challenges faced by legal aid organizations; and a survey and focus groups of California law students on the impact of the cost of legal education and student loan debt on career choices. CalATJ provided the State Bar with written recommendations regarding components of the State Bar Justice Gap Study, and on the draft report and executive summary.

4. A member of CalATJ has been made available to serve on and provide recommendations to an implementation committee convened following the submission of the report of the State Bar's Task Force on Access Through Innovation in Legal Service ("ATILS"). The member's participation focuses on access issues, including any recommendations emanating from the Task Force related to limited license legal technicians or the use of similar paraprofessionals.

The practice guide includes practical and ethical considerations in developing a business plan and providing representation. It will be published during the current fiscal year.

CalATJ prepared and submitted comments on proposed Rules of Court, regulations, and Emergency Rules under consideration by the California Judicial Council and proposed actions by bar associations.
