IN ORDER TO REFLECT THE EXPENSES PAID DIRECTLY BY APS UNDER THE FOUNDATION BUDGET FOR THE SEPARATE FINANCIAL REPORTING OF THE FOUNDATION, AN ENTRY IS MADE ON THE FOUNDATION BOOKS REFLECTING THE COST OF THE SALARY AND OTHER EXPENSES PAID DIRECTLY BY APS. IN THE PAST, THE SALARY COSTS WERE ELIMINATED FROM THE FOUNDATION EXPENSES AND DONATION REVENUE FOR FORM 990 REPORTING PURPOSES UNDER THE BELIEF THEY WERE DONATED SERVICES. HOWEVER, THE SERVICES ARE NOT DONATED TO THE FOUNDATION BY APS.
