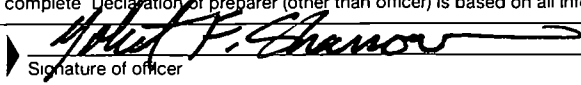

Albert Kahn was born March 21, 1869, Rhaunen, Germany. Died 1942 in Detroit, Michigan.

Albert was the foremost industrial architect of his day, and also was the designer of well known architectural masterpieces such as the Fisher Theater Building, the original GM World Headquarters, many buildings at the University of Michigan (Libraries, Angel Hall, West Engineering, Hill Auditorium, Natural Science Building, and many more), the Belle Isle Aquarium and Conservatory, as well as grand residences such as the Edsel and Eleanor Ford estate. Albert is credited with creating the modern factory with sweeping glass curtainwalls, glass skylights for natural light and healthy ventilation, and fire proof construction which protected the life of workers. He was the architect for Packard, Ford, General Motors, and others, and his factory designs were located throughout five continents. His war-time work created the American Arsenal of Democracy during the first and second world wars. His architecture firm was founded in 1895, and he created it to be a corporation in 1939. Today, Albert Kahn Associates is a thriving, award-winning Architecture-Engineering firm based in Detroit with offices in the Fisher Building.
