The mission of the Friends of Utah County Children's Justice Center is to foster and support the Utah County Children's Justice Center Program (CJC) through raising private and public funds to provide a facility and services in behalf of abused children and their families. The CJC strives to reduce trauma to child abuse victims by facilitating a criminal justice response with a multidisciplinary professional team and providing therapy / services for victims/families in a safe, child-friendly facility known as the Utah County CJC.

The Friends of Utah County Children's Justice Center facilitated access to outpatient mental health therapy in behalf of more than 350 child victims and directly impacted, non-offending family members. These grants were paid directly to community mental health providers for LMI families that would other-wise not receive critically needed therapy for the child abuse trauma that they suffered. Additionally, this amount was significantly leveraged to serve as many children and families as possible through the partial donation of services by these therapists at 50% of the normal fees for services. Specialized, trauma-informed professional therapy is essential for the healing of child abuse victims and their families.

The Provo CJC facility is provided for the full use of the Utah County Children's Justice Center Program, by lease from our Friends of Utah County Children's Justice Center organization, as part of our charitable mission. (A \$1.00 lease fee is paid by Utah County Gov. to validate this lease contract annually, so that full liability coverage for the CJC facility and staff (Utah County employees) is provided under Utah County Government. The depreciation expense for this facility is \$20,960.00 per year. This year the Friends paid to update the roof of this approximately 10,000 sf facility, as well as paying for the installation of critically needed new flooring for entire facility, at a total cost of \$85,280.00.

Additionally, the Friends of Utah County Children's Justice Center paid \$600 for rent of a facility to serve Juab County CJC clients in their own community. The Friends organization has been facilitating efforts of the Utah County Children's Justice Center to support the development of a new CJC in Juab County to serve Juab County children and families during the past two years.

Grants of \$25,425.62 were paid directly to Utah County Government in direct support of Utah County Children's Justice Center Program for professional services, supplies and professional training to maintain specialized skills in order to better serve abused children and their non-offending family members.

Public awareness and educational information regarding child abuse issues in our community and the services that are available to serve child victims/witnesses through the Utah County Children's Justice Center Program were prepared and presented as part of our charitable mission and purpose.

Part II. The Friends of Utah County Children's Justice Center provides the community a donated child-friendly facility for the Utah County Children's Justice Center Program to serve alleged child abuse victims and child witnesses of violent crime. It is leased to Utah County Government for \$1 per year (essentially without charge for this 10,000 square foot facility. The actual value of this space is estimated to be more than \$70,000 per year, if rented. Cash grants to Utah County Government for the Utah County Children's Justice Center Program expenses were made to cover professional training, supplies, essential salary costs, and other program service costs. Additionally, CWICIC, a non-profit corporation, was provided a cash grant for temporary rental of a CJC Program facility co-located in Juab County to better serve the rural child victims of abuse and families who had previously traveled significant distance to receive needed services at the Provo CJC facility.

Part III. Grants for professional therapy were made in behalf of needy individual child abuse victims to allow access to critically needed age-appropriate therapy services provided by a number of licensed mental health treatment providers in our community. Payment was made directly to the therapists (@ 50% of invoiced costs) to pay for these services. Therapists had agreed to direct bill these services to our organization when the individuals served had been previously screened for need and did not have adequate means to be able to access specialized appropriate therapy for child abuse trauma issues.

**Form 990, Part III:** The purpose of the Friends of Utah County Children's Justice Center organization is to support the Utah County Children's Justice Center Program (CJC) through raising private and public funds in behalf of child abuse victims in our community. The purpose of the CJC Program is to reduce trauma for victims of child abuse and child witnesses of violent crimes, particularly sexual and physical abuse, by coordinating and facilitating the criminal justice system and the child protective system responses to these victims through a multi-disciplinary team intervention in a safe, non-threatening, child friendly facility known as the Utah County Children's Justice Center. A child friendly facility and needed major addition to this facility are held in trust for the community by the Friends of Utah County Children's Justice Center, a non-profit, charitable organization.

**1a:** We provide significant funding each year for age-appropriate child abuse victim treatment for abused children and their impacted non-offending family members to promote healing and restoration to productive lives. Specialized professional therapy is essential for the well-being and healing of child abuse victims and child witnesses exposed to trauma.

**1b:** The Friends of Utah County Children's Justice Center provides the child-friendly facility for CJC staff to serve child victims/witnesses in a safe child-friendly environment that brings the necessary criminal justice system, child protection system, medical and mental health professionals together to serve the child where the child is comfortable. This year the Friends organization provided funding to replace the aging roof and flooring of the CJC facility in Provo (\$85,280.00). Additionally, the Friends organization provided remaining needed funding to co-locate CJC services in a facility in Juab County to serve children/families within their local community, rather than having these families and professionals travel significant distance to the Provo location. As planned, the Juab County community is now supporting and providing the CJC program within their local area. An extensive effort is now underway to provide CJC services in an additional new CJC facility to be located in American Fork City to better serve child abuse victims residing in northern Utah County cities and rural area.

**1c:** Additionally, the Friends organization provided direct funding to the CJC Program, which functions under Utah County Government. This support includes training for MDT professionals, medical services, and essential victim support services for children and families.

**Part III, 1d** Public awareness and educational information regarding child abuse issues in our community and the services that are provided to serve child victims/witnesses through the Utah County Children's Justice Center Program are prepared and presented as part of our charitable mission and purpose. A major goal of our annual Hope & Healing Festival is public awareness regarding this critical community issue (shared expense of \$36). This year we utilized social media and multiple donated avenues to encourage our community members to become part of the solution by preventing child abuse and reporting abuse in behalf of the children of our community.
