A database of 8,305 welders, 54 weld agencies, 28 special inspection agencies, 519 special inspectors and 16 fabrication facilities is maintained.

Bookstore: To offer a local source for purchase of code books and code related materials to members and the public. A total of 2,181 books and other documents were sold to our members and the public during the fiscal year.

Training and Education Programs: Provide quality educational opportunities to building officials, plans examiners, inspectors, fire officials, permit technicians and others in the construction industry that provide attendees with valuable information and required continuing education units. A total of 24 classes were held at our educational institute and seminars this year with a total of 1,386 attendees. The code official accreditation program held 4 classes with a total of 36 attendees. 23 WA code officials met the qualifications and have become Accredited Code Officials. Hold quarterly membership meetings and professional development sessions. There were a total of 210 participants attending the quarterly meetings.
