Creative Dance Center: The Creative Dance Center is known locally, nationally, and internationally for innovative teaching methods and the BrainDance. Creative Dance Center provided dance classes and workshops to more than 400 students from ages 2 months to adults. Programming included Caregiver-Child classes, Early Childhood, Children and Teen, Adult classes, and Adaptive Dance for students of all abilities and disabilities. Educator/Community Workshops for adults were offered providing professional development, clock hours, and personal enrichment. Free classes were provided to Mary's Place, an organization providing services to those experiencing homelessness. Mary's Place guests (children and adults) received free dance classes at the Creative Dance Center and with Creative Dance Center teaching artists in the Burien and White Center Mary's Place facilities. Kaleidoscope Dance Company is Creative Dance Center's resident modern dance company of youth ages 7-17. Mosaic Dance Company is comprised of children ages 7-13, offering performance opportunities to Creative Dance Center students. The companies brought educational and interactive concerts to the community providing access to live modern dance for those who may not have the opportunity to see a professional youth ensemble. In 2019-2020 Kaleidoscope and Mosaic activities included Dance Educators Association of Washington fundraising performance, a Community Concert in July at the Creative Dance Center, the Gift of Dance Concert at Shorewood Performing Arts Center, performing at Winterfest in Seattle Center Armory reaching approximately 100 children and adults, CONTINUED ON SCHEDULE O....

The annual Summer Dance Institute for Teachers provides professional development and personal growth for educators, dance teachers, arts specialists, therapists, and more through a 2-week Foundational Course and a 1-week Refresher Course. Both courses provide immersion in the teaching methods developed by CDC Founder, Anne Green Gilbert. These teaching methods are known as brain-compatible dance education. In 2019 29 participants from all over the US and world took part in the Foundational Course and 17 participants from the US and world took part in the Refresher Course. Content for the Summer Dance Institute for Teachers included brain-compatible teaching methods, BrainDance, modern and ballet classes, West African dance, curriculum integration, choreography, lesson planning, historical dance, and best practices for classroom management.
