



Wellness: YES Card Program where staff shows their students that they are seen and loved by requesting funding for an individual student need whether that be clothing, shoes, coats, food, personal items or extra learning supports; Food Education and Gardens; funding un-paid Student Lunch balances.

Parent Group Equity: Supporting our four middle school Parent, Teacher, Student Associations by acting as fiscal sponsor for an equity-based, joint fundraiser that recognizes differences in socioeconomic across school populations. Regardless of how much each PTSA raised, each school received an equitable share of the proceeds to benefit students in all middle schools. Piloted an Elementary Equity Project where each of our 14 Elementary Parent Groups contributed 10% of the proceeds from their individual fundraisers. These funds were disbursed back to every Parent Group using an equity based formula so that lower income schools received a greater share of the proceeds.
