This year, seven local schools participated in the Sister Schools program, collecting 831 boxes with over 20,000 pounds of scholastic
materials donated. With the help of several volunteers we were able to pack and load the boxes on our container. Unfortunately, due
to COVID-19 we were unable to ship the container. It is stored at a safe facility until we are able to travel to Uganda to distribute them

Purchased backpacks (manufactured in Uganda) to distribute easy readers, pencils, crayons and composition books to students
in Uganda. Normally, during our spring distribution trip, day school students (some who walk over 2 hours each way to attend
school) would receive a backpack containing the items listed above. Due to COVID-19 we started paying/collecting supplies but
were unable to distribute to the students.

A team of 5 educators and their families traveled to Uganda to work in our Literacy Centers. They helped run workshops
with English and Literacy teachers at our 5 Literacy Center schools. They also helped distribute, sort and organized donated
