ACCOIN offers the assurance with real life examples that families can progress and even become stronger through childhood cancer treatments and beyond. Special events provide a much needed social network for families to benefit socially, psychologically, and emotionally from gathering informally with other children and families who uniquely understand the challenges and long-term effects of a childhood cancer diagnosis. Approximately 2/3 of children will face some degree of latent effects from the treatments they receive.

Programs:Special programs enhance the lives of cancer patients and their families through various avenues. Our programs address the needs of a diverse set of our population that include teens, siblings, bereaved families, and volunteers from all ethnic and socio-economic backgrounds. Families become empowered through childhood cancer awareness efforts, teenagers with cancer benefit from events and meetings to reduce isolation and address the issues unique to that age group, and sibling support lets siblings know they are not forgotten amidst medical treatment, doctor visits, and illness.
