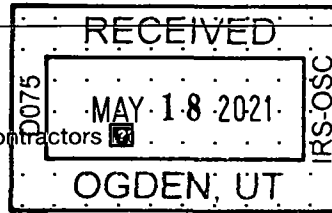

(2) Expense of \$4,406 for Seasonal Sports Awards Banquet food and decorations and Senior Flowers (also listed in Part III). (3) Expense of \$408 for food for Athletic Director and Coaches' Luncheon (4) Expenses of \$863 for Member and Coaches Reception (5) Expenses of \$7,563 for Athletic Field Facility Maintenance and Field Item Procurement - Provided supplies and labor or repainting Women's Softball Team and Men's Baseball Team's Dugouts/Press Box. Procured inflatable tunnel for Football, Soccer, Lacrosse and Administration's use (listed on Line 29 of Part III). (6) Expense of \$370 for Boosters Club Officer and Board of Directors Liability Insurance (7) Expense of \$100. for Sam's Club membership. (8) Expense of \$473. for office and Miscellaneous supplies (9) Expense of \$242 for Bank Fees and Square sales and charging system account.

COMMENT: In the 2018 and 2020 tax years, each year the Laney Athletic Boosters Club donated, a total of \$15,000 to all the athletic teams for their unrestricted use. With the onset of the COVID -19 Virus in 2020, and the unknowns related to sponsorships, memberships and fundraising, we held back on the 2019 tax year payment until October 2020 in which we paid 33 men's and women's athletic teams their share of \$15,000, allocated by their teams roster count. The total number of rostered athletes was 693 athletes. The distribution was deposited in each Coach's school team account for their use in the purchase of equipment, uniforms, etc
