Community of Cantwell, Inc. -- Grant funds received from the Denali Borough were distributed to the fire department and ambulance service via the individual fire department and ambulance checking accounts. The Denali Borough grant funds are reimbursed funds -- CCI does not receive payment until the funds are spent and reported. The fire service and ambulance service write checks for the expenses of their service and CCI is reimbursed by the grant.
