THE MISSION OF CLACKAMAS WOMEN'S SERVICES (CWS) IS TO BREAK THE ISOLATION OF DOMESTIC AND SEXUAL VIOLENCE. INCORPORATED IN 1985 AS CLACKAMAS COUNTY'S FIRST DOMESTIC VIOLENCE SHELTER, CWS IS ONE OF THE MOST COMPREHENSIVE COMMUNITY-BASED ORGANIZATIONS IN THE STATE PROVIDING SERVICES TO SURVIVORS OF DOMESTIC/DATING VIOLENCE, SEXUAL ASSAULT, ELDER AND VULNERABLE ADULT ABUSE, HUMAN TRAFFICKING AND EXPLOITATION, AND STALKING. THE COMPREHENSIVE SLATE OF SERVICES PROVIDED BY CWS INCLUDES EMERGENCY SHELTER, TRANSITIONAL HOUSING, A 24/7 CRISIS LINE, MOBILE ADVOCACY, MENTAL HEALTH COUNSELING, SUPPORT GROUPS, LEGAL ADVOCACY, YOUTH VIOLENCE PREVENTION EDUCATION, CAMP HOPE OREGON, PUBLIC POLICY ADVOCACY AND COMMUNITY EDUCATION. AT OUR SECURE EMERGENCY SHELTER, RURAL OUTREACH OFFICES, CLACKAMAS COMMUNITY COLLEGE, DHS, CAMP HOPE OREGON, AND A SAFE PLACE FAMILY JUSTICE CENTER (ASP-FJC), CWS COORDINATES SERVICES WITH OTHER PUBLIC AND PRIVATE AGENCIES IN ORDER TO BEST SERVE SURVIVORS SEEKING HELP.

EDUCATION AND PREVENTION PROGRAM THE VIOLENCE PREVENTION PROGRAM WORKS TO BUILD A COMMUNITY THAT STANDS AGAINST DOMESTIC AND SEXUAL VIOLENCE BY DEVELOPING YOUNG ROLE MODELS WHO DISRUPT SOCIAL AND CULTURAL NORMS THAT CURRENTLY PERPETUATE VIOLENCE AGAINST WOMEN. THE GOAL IS TO REDUCE THE RATE OF SEXUAL AND DATING VIOLENCE PERPETRATION AND VICTIMIZATION IN OUR COMMUNITY BEFORE THE VIOLENCE OCCURS BY ADDRESSING KNOWN RISK FACTORS, AND PROMOTING HEALTHY RELATIONSHIPS AND BEHAVIORS AMONG YOUTH. CWS IS THE ONLY AGENCY SPECIFICALLY OFFERING SEXUAL AND DATING VIOLENCE PREVENTION PROGRAMMING TO SCHOOLS ACROSS CLACKAMAS COUNTY. THE PROGRAM INTERACTS WITH THOUSANDS OF HIGH SCHOOL AND MIDDLE SCHOOL STUDENTS IN CLACKAMAS COUNTY, PROVIDING THEM WITH CLASSROOM PRESENTATIONS ON DATING/DOMESTIC VIOLENCE, SEXUAL VIOLENCE, AND BYSTANDER INTERVENTION. CWS PROVIDES A TEN-MODULE VIOLENCE-PREVENTION CURRICULUM THAT TARGETS ROOT CAUSES OF GENDER-BASED VIOLENCE. THE TEN MODULES COVER BYSTANDER INTERVENTION, DATING VIOLENCE, SEXUAL VIOLENCE, OPPRESSION, SEXUAL ORIENTATION, HEALTHY SEXUALITY, MEDIA LITERACY, PORNOGRAPHY, AND VICTIM EMPATHY. DURING THIS LAST YEAR THE PROGRAM EXPANDED TO INCLUDE ELEMENTARY SCHOOLS THROUGH OUR COMMUNITIES FOR SAFE KIDS PROGRAM AS WELL AS LAUNCHED A NEW COACHING BOYS INTO MEN PROGRAM. LAST YEAR, THE VIOLENCE PREVENTION PROGRAM HIRED TWO NEW FACILITATORS TO LAUNCH COMMUNITIES FOR SAFE KIDS, A SCHOOL-BASED PROGRAM FOR K-6TH GRADERS DESIGNED TO PREVENT CHILDHOOD SEXUAL ABUSE. THE PROGRAM HELPED MEET STATEWIDE REQUIREMENTS FOR SCHOOLS TO COVER THE TYPES OF VIOLENCE CHILDREN MAY EXPERIENCE INCLUDING SEXUAL ABUSE, DOMESTIC VIOLENCE, AND TEEN DATING VIOLENCE. LESSONS PROVIDED ARE TRAUMA-INFORMED AND CULTURALLY-SPECIFIC, UTILIZING PUPPETS IN AN "EDU-TAINMENT" FORMAT TO TEACH IN A FUN AND LIVELY WAY. THIS PROGRAM WAS PROVIDED IN THE CANBY SCHOOL DISTRICT; STUDENTS WERE ENTHUSIASTIC ABOUT TO THE PUPPET SHOWS AND LOOKED FORWARD TO THE WORKSHOPS. CHILDREN AND YOUTH SERVICES THE CHILDREN AND YOUTH SERVICES PROGRAM IS DEDICATED TO INTERRUPTING THE GENERATIONAL CYCLE OF DOMESTIC AND SEXUAL VIOLENCE. THE PROGRAM CONSISTS OF SEVERAL EVIDENCE BASED COMPONENTS: CAMP HOPE OREGON AND PATHWAYS PROGRAM, THE EVIDENCE BASED TRAUMA RECOVERY EMPOWERMENT MODEL LOVE AND LIFE GROUP FOR TEENS, A WINDOWS BETWEEN WORLDS ART-BASED THERAPY, THE MAKE PARENTING A PLEASURE CURRICULUM, ADVOCACY SERVICES, INDIVIDUAL AND FAMILY COUNSELING, ANIMAL ASSISTED THERAPY AND FIELD TRIP EXPERIENCES FOR CHILDREN IN THE EMERGENCY SHELTER PROGRAM. THE PROGRAM REDUCES THE IMPACT OF DOMESTIC AND SEXUAL VIOLENCE ON TO YOUNG OREGONIANS BY PROMOTING RESILIENCY THROUGH INDIVIDUAL, FAMILY, AND COMMUNITY PROTECTIVE FACTORS AND BY BUILDING SKILLS TO INCREASE THE HEALTHINESS OF RELATIONSHIPS WITHIN THEIR LIVES AND OFFERS HEALING AND HOPE FOR CHILDREN AND YOUTH WHO HAVE EXPERIENCED OR WITNESSED DOMESTIC OR SEXUAL VIOLENCE. THIS YEAR THE PROGRAM INCREASED THE NUMBER OF PARENTING CAFES THAT PROVIDE ON-GOING PEER-BASED SUPPORT AND COMMUNITY BUILDING SPACES FOR PARENTS AND CAREGIVERS, ADDED FULL TIME MOBILE YOUTH ADVOCATES, CONTINUED PARTICIPATION IN THE CLACKAMAS COUNTY STUDENT THREAT ASSESSMENT PROTOCOL AND EXPANDED THE NUMBER OF SUPPORT GROUPS AND AFTER SCHOOL PROGRAMMING AVAILABLE IN THE SCHOOLS. CAMP HOPE AMERICA OREGON COMPLETED ITS SEVENTH YEAR OF CAMP. NOTABLE CHANGES FROM PRIOR YEARS INCLUDED MORE OLDER CAMPERS (AGES 11-16) THAN YOUNGER CAMPERS (AGES 7-11) ATTENDING; INCREASED NUMBER OF CAMP COUNSELORS ONSITE WITH THREE CAMP COUNSELORS WHO WERE FORMER CAMPERS; AND OVER 1,140 VOLUNTEER AND STAFF HOURS PROVIDED BY THE CAMP HOPE COMMUNITY. PROMOTORAS AND LATINA SERVICES THE PROMOTORAS PROGRAM TRAINS MEMBERS OF THE LATINA COMMUNITY TO BECOME PARAPROFESSIONALS, CALLED PROMOTORAS, TO INCREASE THE ACCESSIBILITY OF DOMESTIC AND SEXUAL VIOLENCE SERVICES TO THE LATINA COMMUNITY IN CLACKAMAS COUNTY. PROMOTORAS HELP BRIDGE THE CULTURAL, LANGUAGE, AND ECONOMIC BARRIERS BETWEEN SERVICE PROVIDERS AND SURVIVORS IN THE LATINA COMMUNITY. OUR INTENTION IS TO WORK WITHIN THE LATINA COMMUNITY TO IDENTIFY THEIR NEEDS AND ADJUST PROGRAMMING TO BETTER SUPPORT. THE PROMOTORAS MODEL RAISES THE VOICES OF LATINA WOMEN WITHIN THE COMMUNITY, AS WELL AS IN THE SYSTEMS WHERE THEIR VOICES HAVE NOT OFTEN ENOUGH BEEN INCLUDED. WE NOW HAVE TWO COHORTS OF PROMOTORAS, WHO VOLUNTEERED OVER 200 HOURS OF COMMUNITY SUPPORT, OUTREACH, AND REFERRALS IN 2019. NOTABLE COLLABORATIONS INCLUDED EVENTS WITH BRIDGING CULTURES, TODOS JUNTOS, OREGON COALITION AGAINST DOMESTIC AND SEXUAL VIOLENCE, HISPANIC INTERAGENCY NETWORKING TEAM, AND EL PROGRAM HISPANO. PROMOTORAS PARTICIPATED IN THE WOUNDED HEART & RESILIENCE PROJECT FOR SEXUAL ASSAULT AWARENESS MONTH IN APRIL. PROMOTORAS HAVE ATTENDED THE ARTE SANA CONFERENCE, A NATIONAL BILINGUAL CONFERENCE, AND PRESENTED ON THE PROMOTORAS MODEL TO ATTENDEES FROM ACROSS THE COUNTRY. ESTABLISHED PROMOTORAS ALSO SERVE AS MENTORS TO EACH NEW COHORT IMPROVING CWS AND THE LARGER COMMUNITY’S RESPONSE TO DOMESTIC AND SEXUAL VIOLENCE FOR MARGINALIZED SURVIVORS AND ENHANCING INTERGENERATIONAL COMMUNITY RELATIONSHIPS AND COLLABORATION. IN THE UPCOMING YEAR, CURRENT PROMOTORAS WILL CONTINUE TO PARTICIPATE IN REGULAR PEER-SUPPORT MEETINGS AND CONDUCT CONCERTED OUTREACH TO LATINA COMMUNITIES THROUGH TABLING EVENTS, COMMUNITY LISTENING SESSIONS, TOURS OF A SAFE PLACE, CHARLAS (INFORMATION FORUMS), AND THROUGH THEIR PERSONAL AND PROFESSIONAL NETWORKS; THE LATINA SERVICES COORDINATOR WILL BEGIN PROCESS OF ESTABLISHING A THIRD PROMOTORAS COHORT (TO OPERATE IN RURAL CLACKAMAS COUNTY). COMPLEMENTING THIS WORK IS THE LATINA LEADERSHIP TEAM, COMPRISED OF REPRESENTATIVES FROM ALL SERVICE AREAS OF OUR AGENCY. THE OBJECTIVES OF THE TEAM ARE TWOFOLD: DEVELOP LEADERSHIP SKILLS AND RAISE THE VOICES OF LATINA STAFF AND PARTICIPANTS. THE LATINA LEADERSHIP TEAM ACCOMPLISHES THE LATTER THROUGH EXTENSIVE OUTREACH TO THE LATINA COMMUNITY, DRAWING FROM SURVIVOR FEEDBACK TO IDENTIFY BARRIERS TO SERVICES FOR MARGINALIZED COMMUNITIES AND COLLABORATIVELY DEVELOPING SOLUTIONS TO ENSURE EQUITABLE ACCESS. LEGAL EMPOWERMENT ACCELERATOR PROGRAM (LEAP) CWS LAUNCHED THE LEGAL EMPOWERMENT ACCELERATOR PROGRAM (LEAP), THE FIRST PROGRAM OF ITS KIND IN OREGON. WITHOUT LEGAL ASSISTANCE, SURVIVORS FACE PROFOUND BARRIERS ON THEIR PATHWAYS TO SAFETY, JUSTICE, AND HEALING. HIGH-PRIORITY AREAS INCLUDE PROTECTIVE ORDERS, CHILD SUPPORT, CUSTODY, DIVORCE, IMMIGRATION STATUS, WRONGFUL TERMINATION, LANDLORD-TENANT MATTERS, AND BANKRUPTCY. WHILE ACCESS TO LEGAL ASSISTANCE IS KEY TO ACHIEVING SAFETY AND SELF-SUFFICIENCY NATIONAL STUDIES SHOW THAT ACCESS TO AN ATTORNEY CAN INCREASE SURVIVORS LIKELIHOOD OF OBTAINING A CIVIL RESTRAINING ORDER FROM 32% TO 86% THIS NEED REMAINS UNMET FOR THE MAJORITY OF SURVIVORS AND THEIR CHILDREN. LEAP WILL HELP LAUNCH THE SOLO PRACTICE CAREERS OF NEW ATTORNEYS, AS WELL AS THOSE RETURNING TO THE PRACTICE AFTER AN EXTENDED ABSENCE. ATTORNEYS PARTICIPATING IN LEAP AGREE TO REPRESENT CWS REFERRED PARTICIPANTS WITH 15 HOURS OF PRO-BONO AND 35 HOURS OF SLIDING SCALE LEGAL SERVICES MONTHLY. IN EXCHANGE, THESE NEW SOLO PRACTITIONERS ARE PROVIDED OFFICE SPACE AND EQUIPMENT, PRACTICE INSURANCE, ASSISTANCE WITH DUES AND FEES; AND WILL GAIN INVALUABLE PROFESSIONAL EXPERIENCE WHILE LEARNING IN A COLLABORATIVE, SUPPORTIVE ENVIRONMENT WITH MENTORSHIP.

IN THIS SUPPORTIVE ENVIRONMENT, SURVIVORS CAN STEP AWAY FROM THEIR CURRENT HOME LIVES, REGAIN THEIR STRENGTH, AND INDIVIDUALLY SHAPE THE WAYS THEY WANT TO MOVE FORWARD IN THE WORLD. IT IS A PLACE WHERE PARTICIPANTS FEEL TRUSTED TO MAKE THEIR OWN LIFE CHOICES AND DO WHAT IS MEANINGFUL TO THEM. (CONTINUED ON SCHEDULE O)THE VILLAGE EMERGENCY SHELTER ACCOMMODATES UP 15 ADULTS AND 25 CHILDREN AT A TIME, SERVING APPROXIMATELY 250 SURVIVORS EACH YEAR. THE CWS HOUSING PROGRAM SERVES OVER 150 HOUSEHOLDS ANNUALLY THROUGH A HOUSING FIRST MODEL THAT INCLUDES TRANSITIONAL HOUSING, HOMELESS PREVENTION, PERMANENT SUPPORTIVE HOUSING, RAPID REHOUSING AND ON-GOING SUPPORTIVE SERVICES. THIS INCLUDED DIRECT RENTAL ASSISTANCE AND COMPREHENSIVE CASE MANAGEMENT, WHICH HELPED PARTICIPANTS AFFORD THE COSTS OF LIVING WHILE BUILDING THE SKILLS NEEDED TO NAVIGATE HOUSING BARRIERS AND THE TIME TO HEAL FROM THE TRAUMA THEY HAVE EXPERIENCED. THE PROGRAM OFFERS HOUSING ASSISTANCE TO SURVIVORS: PREVENTION AND RAPID REHOUSING FUNDS SHORT-TERM ASSISTANCE PROVIDED FUNDING FOR PEOPLE TO EITHER STAY STABLY HOUSED OR RETURN TO SAFE AND STABLE HOUSING; TRANSITIONAL HOUSING FUNDS MEDIUM ASSISTANCE PROVIDED THREE TO SIX-MONTH SUBSIDIES TO ALREADY HOUSED SURVIVORS IN ORDER FOR THEM TO SECURE EMPLOYMENT BENEFITS AND OTHER COMMUNITY RESOURCES; PERMANENT SUPPORTIVE HOUSING FUNDS LONG-TERM ASSISTANCE PROVIDED FOR AS LONG AS NEEDED ASSISTANCE. THIS FUNDING ALLOWED US TO SUPPORT SURVIVORS WHO HAVE DISABILITIES OR HIGH BARRIERS TO HOUSING; POPULATION SPECIFIC HOUSING PROGRAMS FUNDING SPECIFICALLY DEDICATED TO PRIORITIZE POPULATIONS SUCH AS THE BIPOC COMMUNITY, IMMIGRANT AND REFUGEE COMMUNITY AND VICTIMS OF HUMAN TRAFFICKING.

THE CO-LOCATION AND THE INTEGRATION OF THESE SERVICES (CONTINUED ON SCHEDULE O) ADDRESSES MANY ISSUES OF ACCESS AND PROVIDES COHESIVE SERVICES THAT WERE PREVIOUSLY NON-EXISTENT AND/OR SPORADICALLY OFFERED. THE OPENING OF ASP-FJC CREATED THE PIVOTAL FOUNDATION FOR ACHIEVING OUR COMMUNITY'S VISION TO IMPLEMENT A COORDINATED APPROACH TO ADDRESS THE SHATTERING IMPACTS OF DOMESTIC VIOLENCE, SEXUAL ASSAULT, STALKING, DATING VIOLENCE, ELDER ABUSE, SEXUAL EXPLOITATION AND TRAFFICKING THROUGH A COMMON VISION, VAST-REACHING IMPROVEMENTS AND SYSTEMIC CHANGE, SERVICE INTEGRATION ACROSS MULTIPLE DISCIPLINES, CHANGES IN POLICY AND PRACTICE, INCREASED INVESTMENTS AND A ROBUST WELL-FUNCTIONING PUBLIC/PRIVATE PARTNERSHIP. CWS ADVOCATES ASSIST SURVIVORS IN NAVIGATING THESE SYSTEMS AND ACCESSING THE SERVICES THAT THE PARTICIPANT CHOOSES. CWS PROVIDES OVER 75% OF THE SERVICES OFFERED AT A SAFE PLACE INCLUDING MENTAL HEALTH COUNSELING, CRISIS INTERVENTION AND LONG TERM ADVOCACY AND CASE MANAGEMENT SERVICES, ECONOMIC EMPOWERMENT CLASS, PARENTING SUPPORT, RURAL OUTREACH, LEGAL ADVOCACY, HOUSING ASSESSMENTS, COMMUNITY EDUCATION AND SO FORTH. THERE ARE AN AVERAGE OF 25 VISITS DAILY OF VICTIMS SEEKING SUPPORT THROUGH THIS OFFICE AND CWS PROVIDED OVER 25,000 UNITS OF SERVICE THIS YEAR. RECENTLY, CWS WORKED WITH PARTNERS AT ASP-FJC TO LAUNCH A NEW ELDER ABUSE COORDINATED COMMUNITY RESPONSE THAT PROVIDES SPECIALIZED TRAINING ACROSS MULTIPLE DISCIPLINES, INCREASES SERVICE CAPACITY AND BUILD A COLLABORATIVE RESPONSE TO ABUSE IN LATER LIFE. TO ENHANCE ACCESS AND STRENGTHEN PARTNERSHIPS, CWS PROVIDES SUPPORT FOR SURVIVORS ACCESSING SERVICES THROUGH OREGON DEPARTMENT OF HUMAN SERVICES (DHS) BRANCHES IN CLACKAMAS COUNTY BY INCREASING THE NUMBER OF DHS CO-LOCATED ADVOCATES. THIS RESULTED IN AN INCREASE OF PARTICIPANTS REFERRED FROM DHS AND CONTRIBUTED TO AN OVERALL INCREASE IN REFERRALS FOR COMMUNITY-BASED SERVICES. WE CONTINUED TO PROVIDE QUARTERLY TRAININGS FOR DHS STAFF ON DOMESTIC VIOLENCE AND TRAUMA. IN ADDITION, CWS HAS A RURAL OUTREACH OFFICE AND HAS A SEXUAL ASSAULT ADVOCATE LOCATED AT CLACKAMAS COMMUNITY COLLEGE.

ADDITIONALLY, SOCIAL WORK STUDENT INTERNS PROVIDE ADDITIONAL CAPACITY TO SERVE UNINSURED, OTHER INSURED, (CONTINUED ON SCHEDULE O) OR FOLKS FOR WHOM IT MAY NOT BE SAFE TO BILL INSURANCE. WE CONTINUED TO PRIORITIZE THE VALUES OF EQUITY AND INCLUSION FOR UNDERSERVED POPULATIONS. WE HAVE A FULL TIME LATINA COUNSELOR WHO PROVIDES CULTURALLY SPECIFIC COUNSELING SERVICES TO SURVIVORS WHO ARE OFTEN UNINSURED, AND FACE LANGUAGE AND CULTURAL BARRIERS. THE COUNSELING PROGRAM OFFERED SERVICES AT OUR OFFICE IN SANDY, INCREASING ACCESSIBILITY FOR SURVIVORS WHO LIVE IN RURAL AREAS OF THE COUNTY. NEARLY 40% OF SURVIVORS WHO ACCESSED COUNSELING SERVICES IDENTIFIED AS LATINA AND 24% LIVED IN RURAL PARTS OF CLACKAMAS COUNTY. CWS COUNSELING SERVICES ARE PROVIDED IN THREE CERTIFIED COUNSELING LOCATIONS INCLUDING A SAFE PLACE FAMILY JUSTICE CENTER, CWS' RURAL OUTREACH OFFICE, AND THE CWS' CLACKAMAS COMMUNITY COLLEGE OFFICE. IN SOME CIRCUMSTANCES, WE ALSO MEET WITH FOLKS IN THEIR HOMES, AT SHELTER OR AT SCHOOL. THIS FLEXIBILITY HELPS INCREASE ACCESSIBILITY AND EQUITY IN SERVICES. CLINICIANS USE EVIDENCE BASED TREATMENT MODALITIES, INCLUDING COGNITIVE BEHAVIORAL THERAPY, EMDR SENSORIMOTOR PSYCHOTHERAPY, MINDFULNESS, MOTIVATIONAL INTERVIEWING, AS WELL AS ART AND PLAY-BASED INTERVENTIONS WITH KIDS INCLUDING A WINDOW BETWEEN WORLDS.
