CCHP regularly and reliably transforms the lives of participants in lasting and profound ways; it changes the experience of living and sometimes dying with cancer. We currently offer six CCHP retreats each year. Since 2012, we also have been holding three-day Cancer Help Program trainings for Bay Area Young Survivors (BAYS)- a community of young adults who have metastatic breast cancer. Arlene Allsman serves as the coordinator of CCHP.
