SHELTER STAFF PROVIDE RESOURCES TO HELP THE FAMILY ACCOMPLISH THEIR OBJECTIVES. SHELTER STAYS VARY; THE CURRENT AVERAGE IS 54 DAYS. SHELTER CLIENTS ARE ALSO PROVIDED WITH EMPLOYMENT COUNSELING, HOUSING ASSISTANCE, REFERRALS FOR FINANCIAL AND LEGAL AID, AND MANY OTHER RESOURCES. THIS PROGRAM IS DESIGNED TO ADDRESS THE GAP IN SERVICES BETWEEN WHEN POLICE OFFICERS RESPOND TO A DOMESTIC VIOLENCE CALL AND WHEN A SURVIVOR CONNECTS WITH SAFE NEST AND OTHER NEEDED RESOURCES TO PRESERVE THEIR SAFETY.
