As a health precaution and due to the State's limitation on large gatherings, the Museum was closed in mid March and remained closed through the end of the fiscal year and into the Fall. Museum management was forced to make difficult decisions including the release of 16 staff members with the plan to rehire upon reopening. The remaining staff are working on the plan for reopening by recalibrating 15 interactive exhibits, utilizing timed ticketing, one way routing of visitors, and activating an outdoor space to extend capacity. The reopening date is still to be determined.
