Professional and Cultural Exchanges: NNIC implements a range of grant projects funded mainly by the U.S. Department of State (DOS) and USAID to advance U.S foreign diplomacy efforts. Participants from more than 100 countries visit Reno and Northern Nevada for short-term cultural and professional exchanges to meet Americans, advance professional skills and foster positive relations through dialogue and understanding. Due to the pandemic, NNIC hosted only 52 participants on three different exchange programs in person through the beginning of March (compared to 500+ exchange participants previously), and then pivoted to implementing virtual programs for the remainder of the year.

## **Form 990, Part III, Line 4b:**

Refugee Resettlement:NNIC resettles refugees under the guidance of the DOS and with funding from both DOS and the Department of Health and Human Services. Services to refugees, asylees, victims of international human trafficking includes assistance with wrap-around services including housing, employment, education, ESL, health and mental health services. Due to the pandemic, NNIC resettled only 20 refugees, plus three victims of trafficking and 2 asylee. The Emergency rental Assistance Fund served 11 Families affected by the Pandemic.

Language Bank and Community Connections:NNIC's language access program offers interpretation and translation services on a fee-for-service basis to local courts, the school district, administrative offices of state and local government as well as the private sector. NNIC also offers educational seminars for the public to engage them with international visitors, refugees and immigrants. During the pandemic, NNIC offered 246 interpretations and translations to 88 clients, plus offered 615 Over-the-Phone (OPI) and Video Remote Interpretations (VRI).
