EMERGENCY FOOD ASSISTANCE
In fiscal year 2020 the Food Pantry distributed 815,001 pounds of food to over 17,407 families or 56,944 individuals. The food distributed is a combination of government commodities, purchased food and donated food from the Food Bank of Alaska, retail stores, individuals and congregations. The LSSA Food Pantry is open four days a week.
LSSA also operates a Mobile Food Pantry every Tuesday in the parking lot of Lutheran Church of Hope. In FY2020 we distributed 282,645 pounds of food to 6,710 households or 20,130 individuals.

EMERGENCY HOUSING SERVICES
LSSA operates two housing units that benefit individuals that would otherwise be homeless. Our Roosevelt House provides safe and affordable housing for low income individuals with long term behavioral health issues and other medical problems. We served six full-time tenants in FY2020.
The Transitional Living Program (TLP) provides assistance and transitional housing for single homeless men. Our goal of this program is to break the cycle of homelessness and help the residents find sustainable employment and thus sustainable housing. Clients are required to have a job or secure one in the first 30 days of occupancy and are required to be free of all substance abuse. Residents also are required to share in household chores and yard work. In FY2020 we served only 9 men as we had to establish new Covid 19 protocols.

DIRECT ASSISTANCE
LSSA's Direct Assistance Program covers three main areas. First is Neighbor to Neighbor, where we offer assistance to individuals who are looking for help obtaining a state ID, drivers license, birth certificate, clothing vouchers, bus passes and prescription care. Second area is with assistance with rides to and from medical or therapy appointments. Our third area helps those who were medevacked into Anchorage for medical care. We provide assistance with housing, food and transportation until they are released to return home. We then assist them with transportation home to rural Alaska. In total for FY2020 we assisted 1,920 individuals/families with direct assistance funds.
In March 2020, due to the shutdown because of Covid 19 we distributed \$413,000 in rental and utility assistance to 431 households.
