School of Arts & SciencesThe School of Arts & Sciences consists of four schools: School of Cinema & Media Arts; School of Fine Arts & Communication; School of Humanities & Social Sciences; and School of Science, Technology, and Health.The School of Cinema & Media Arts focuses on equipping students to serve as an observer, interpreter, and creator of mass media through a Christian worldview. There are four areas of study to select from: game design and interactive media, production, writing for the screen, and entertainment producing. The School of Cinema & Media Arts is ranked Variety as one of the 50 best film programs in the world, and offers one Bachelor's degree program with a choice of nine concentrations, including cinematography, entertainment business, production, and visual effects.The School of Fine Arts and Communication is where students explore new ways to create, tell and distribute stories because every discipline taught is a channel through which students can impact the world and express their faith -- with words, visuals and sound. The programs give students the opportunity to become proficient and powerful storytellers. The School of Fine Arts and Communication offers 23 Bachelor's degree programs, one Master's degree program, and three certificate programs. Degrees available include B.F.A. in Studio Art, B.S. in Design, B.A. in Music, B.A. in Communication Studies, and M.A. in Public Relations and Reputation Management.The School of Humanities & Social Sciences aims to look at humankind's similar and disparate systems, beliefs, languages and cultures and to gain an understanding through the literary masterpieces of great thinkers. They provide context for traditions and folklore and let philosophy collide with history and politics, in an attempt to make sense of the world from a human perspective, as well as a biblical perspective. The School of Humanities & Social Sciences offers 13 Bachelor degree programs. Degrees available include B.A. in English, B.A. in Political Science, and B.A. in Sociology. The School of Humanities & Social Sciences also offers the Torrey Honors College, which is Biola University's undergraduate honors program.The vision of the School of Science, Technology and Health at Biola University is to equip a new generation of ethically thoughtful professionals in the sciences and health care, grounded in a Christian worldview, educated in an academically rigorous environment, ready to assume positions of leadership, and able to provide the clear moral vision the world desperately needs. The School of Science, Technology and Health offers 27 Bachelor's degree program and two Master's degree programs. Degrees available include B.S. in Nursing, B.S. in Kinesiology, B.S. in Chemistry, and B.S. in Engineering Physics. The School of Science, Technology and Health also offers the Stewart Science Honors Program which is a highly selective honors program that is academically rigorous and is guided by research and technology.As of Fall 2019, the School of Arts & Sciences' enrollment is 2,425 undergraduate students and 48 Masters students. In March 2020, The Biola Conservatory partners launched "String Sprouts," providing free instruments and class lessons to children who live below the poverty level. Every year the School of Cinema & Media Arts hosts a Screenwriting Contest where students submit their original screenplays for a chance to win a \$10,000 scholarship. In December 2019, three students participated in the 2019 Mathematical Association of America Putnam Competition, which is a prestigious national competition administered by the Mathematical Association of America.

School of EducationThe School of Education exists to train up those who desire to make an impact as educators in classrooms, administration buildings, homeschools, the mission field, and beyond. A wide selection of rigorous, biblically centered academic offerings are available -- ranging from undergraduate and graduate programs to teaching credentials and certificates, as well as K12 as well as homeschool education through the Eight-Week Clinic Courses for grades 1 through 6. The School of Education offers six Bachelor's program degrees, four Master's program degrees, and seven certificate programs. Degrees available include B.A. in Early Childhood, B.A. in Liberal Studies (Multidisciplinary), and M.A. in Education.As of Fall 2019, the School of Education's enrollment is 209 undergraduate students and 246 Masters students. In March 2020, Biola hosted the Association of Christian Schools 2020 Early Education Conference.

Crowell School of BusinessThe Crowell School of Business prepares students academically with a foundational business education while nurturing their Christian commitment through solid biblical integration in courses and contact with faculty and staff. The mission of the Crowell School of Business is to equip students to develop a Biblical worldview so as to see business as ministry: to prepare students for excellence and leadership in their career, to be strong in mind and character, and mature in faith so that they will make an impact for God in this time and place. The Crowell School of Business offers seven Bachelor degree programs and three Master's degree programs. Degrees available include B.S. in Accounting, B.S. in Business Administration, and Masters of Business Administration.As of Fall 2019, the Crowell School of Business's enrollment is 578 undergraduate students and 102 Masters students. Every year the Crowell School of Business hosts the Biola Startup Competition where undergraduate and graduate students, as well as recent alumni, are invited to pitch their concept for a business or nonprofit, develop a business plan, and compete for capital. This year, first place was awarded to Boba for Missions. The Crowell School of Business also hosted the Meet the Money Managers event to assist business students with developing their networking skills. In addition, every other month, the Crowell School of Business hosts the Distinguished Speaker Series, where prominent business leaders are invited to speak with students.

Rosemead School of PsychologyRosemead School of Psychology is a top psychology school for Christians who want to integrate their faith with their field. Rosemead School of Psychology brings together the scientific, research-driven study of human behavior with biblical perspectives on human flourishing. Students are equipped with knowledge and skills for professional roles in clinical psychology, therapy, counseling, teaching and research. Rosemead School of Psychology offers two Bachelor's degree programs and two Doctoral degree programs. Degrees available include B.A. in Psychology and Ph.D. in Clinical Psychology.As of Fall 2019, the Rosemead School of Psychology's enrollment is 382 undergraduate students, 44 Masters students, and 119 Doctoral students. In November 2019, the American Psychological Association recognized two of Biola University's professors. Professor Liz Hall received the Distinguished Service Award from the APA Society for the Psychology of Religion and Spirituality and Professor Laura Dryjanska was selected by the APA division of International Psychology to receive an Outstanding Early Career Psychologist Award.

Cook School of Intercultural StudiesThe Cook School of Intercultural Studies exists to equip students to communicate, live and work effectively in culturally diverse contexts, to make disciples of all peoples, and to impact the world for the Lord Jesus Christ. It's diverse faculty, with overseas and missionary experience in nearly 100 countries, equips students for careers in a wide variety of fields globally and domestically. The Cook School of Intercultural Studies offers two Bachelor degree programs, seven Master's degree programs, three Doctoral programs, and two certificate programs. Degrees available include B.A. in Intercultural Studies, M.A. in Missions, and Ph.D. in Intercultural Education.As of Fall 2019, the Cook School of Intercultural Studies' enrollment is 67 undergraduate students, 116 Masters students, and 146 Doctoral students. The Cook School of Intercultural Studies publishes The International Journal of Christianity and English Language Teaching, which is an annual publication relating to English language teaching and Christian English language teachers.

Summer SessionSummer session provides students with the opportunity for a greater degree of flexibility in planning their total program. Students may enrich their course of study and reduce the overall time to completion or decrease their regular course load by careful selection of summer session courses. Courses may be applied to both the degree and the teaching credential programs. Instruction is offered in standard courses by the Biola faculty and capable visiting professors.

ResearchResearch includes various grants that Biola University has secured from third parties, which includes administration of grants, as well as the research being performed. Research also includes The Center of Marriage & Relationships which equips students, couples and churches with the tools needed to build happy, healthy friendships, relationships and marriages. Public ServicesPublic Services includes Biola University's Biola Youth program and a counseling center for the community.

The Talbot School of Theology also partners with the Crowell School of Business to offer a Masters of Management, Nonprofits Organizations. As of Fall 2019, the Talbot School of Theology's enrollment is 252 undergraduate students, 1,011 Masters students, and 218 Doctoral students. Talbot School of Theology engages with its students and community through its weekly podcast "Think Biblically," "The Good Book Blog, and the Talbot Magazine which is published twice a year. In addition to inviting guest speakers throughout the year, Talbot School of Theology participated in conferences, such as the Women in Apologetics Conference with the theme "Find Your Voice and the EPS Apologetics Conference.

Merit awards are based on eligibility criteria such as academic, athletic, and music abilities. These typically have academic or participation requirements for renewal. Continued eligibility based on stated requirements is monitored by the Financial Aid office or by the office that makes the awards. Need-based awards are typically awarded based on specific formulas that are based on an institutional or federal cost amount combined with the federal EFC determined by the FAFSA. Continued eligibility is normally contingent on ongoing need in subsequent years. Most of the grants and scholarships awarded by Biola are funded from general funds; however, a portion are funded from restricted funds that have been provided by donors, and are awarded based on the eligibility criteria established by the donors. Some of these funds are awarded by various campus departments, and some through an application process administered by the Financial Aid Office. The Financial Aid Office works closely with accounting and finance offices to monitor availability of funds from both the general fund and restricted fund accounts.
