BARC has reviewed its tax positions and determined that an accrual for uncertain income tax positions and adjustments to the tax provision was not necessary. With few exceptions, as of June 30, 2020 and 2019, BARC is no longer subject to U.S. federal and state income tax examinations for fiscal years before 2016 and 2015, respectively.
