"HCA" then converted to a 6/30 fiscal year end. Annual expenditures vary from year to year and are expected to grow as operations expand. Lobbying expenditures however remain fairly low and stable as shown above. it is important to note that the nature of these lobbying expenditures are as described in the first paragraph and thereby should not jeopardize the exempt status of "hca"."HCA" exists primarily to represent 40 affiliates in educational and support activities including lobbying and activites on their behalf. The alternative would be for each of the 40 affiliates to report their lobbying activities expenditures separately. if the 40 affiliates separately reported lobbying expenditures these expenditures would be insubstantial much like the "east bay" example above. In order to be efficient, however, all of the 40 affiliates lobbying and advocacy activities are concentrated in "hca".Based on the above "hca" should be viewed as having insubstantial lobbying and advocacy activities for purposes of form 990 schedule c.
