DVAC'S LEGAL AND ADVOCACY SERVICES HAVE REACHED THE COFA (COMPACT OF FREE ASSOCIATION) COMMUNITY, THE KOREAN COMMUNITY, THE NATIVE HAWAIIAN COMMUNITY, THE LGBTQ+ COMMUNITY, THE JAPANESE COMMUNITY AND CONTINUED WITH THE FILIPINO COMMUNITY. DVAC'S ADVANCE PROGRAM PROVIDES A WIDE VARIETY OF CASH ASSISTANCE OPTIONS TO SURVIVORS, COMPLEMENTING THE AGENCY'S EXISTING ARRAY OF AUXILIARY ASSISTANCE TO FAMILIES ON THE PATH TO SAFETY AND SELF-SUFFICIENCY. SURVIVORS RECEIVE FUNDS FOR RENT, UTILITIES, TRANSPORTATION, LEASE APPLICATIONS (FIRST AND LAST MONTH'S RENT), AND CAR REPAIRS, IN ADDITION TO TUITION ASSISTANCE, BUS VOUCHERS, AND CHILD CARE SUPPORT. DVAC'S STABILITY COORDINATOR SEAMLESSLY ADMINISTERS CASH ASSISTANCE AND ANCHORS THE PROGRAM. DURING 2020, DVAC'S ADVANCE PROGRAM ASSISTED SEVENTY-SIX (76) CLIENTS ON THEIR JOURNEY TO SAFETY AND STABILITY. DVAC'S HALE MALUHIA PROGRAM PROVIDES PERMANENT SUPPORTIVE HOUSING FOR SURVIVORS OF DOMESTIC VIOLENCE ON O'AHU, ADDRESSING THE NEEDS OF SURVIVORS AND THEIR FAMILIES WHO HAVE BECOME HOUSELESS AS A RESULT OF THE ABUSE. THROUGH THIS PROGRAM, SURVIVORS ARE PROVIDED HOUSING AND SUPPORT SERVICES SUCH AS ADVOCACY, LEGAL REPRESENTATION, SUPPORT GROUPS, THERAPY SESSIONS, HEALTH AND WELLNESS INITIATIVES, CAREER DEVELOPMENT AND FINANCIAL LITERACY CLASSES. WITH STABLE HOUSING AND SUPPORT SERVICES TAILORED TO THEIR NEEDS, RESIDENTS WILL MOVE FORWARD ON THEIR JOURNEY TO SAFETY, STABILITY, AND SECURITY - AWAY FROM VIOLENCE. DVAC'S HALE MALUHIA PROGRAM HAS PROVIDED HOUSING FOR 22 DV SURVIVOR FAMILIES.
