DURING THIS FY, THERE WERE 40 FOUNDATION SCHOLARSHIP AWARDED. USING THE SAME COMPETITIVE SCHOLARSHIP PROGRAM BUT WITHOUT REGARD TO FOUNDATION MEMBERSHIP, THE FOUNDATION ADMINISTERED AND AWARDED THREE DISTANCE EDUCATION ALUMNI SCHOLARSHIPS AS WELL.
