The initiative has successfully implemented programs in 16 sites in central Ohio and one site in Cincinnati, Ohio through training and mentoring of center teachers and directors. The CC: B-3 initiative has assisted in improving over all center quality, with several centers receiving increased quality ratings from the state's Step Up to Quality child care center rating system. CC: B-3 impacted on the quality of care for over 280 infants and toddlers in child care centers in central Ohio during this reporting year.
