Woodward Trust was established by an act of the Ohio State Legislature which structured oversight and control of its operation through the appointment process for its trustees - 3 trustees appointed by the Cincinnati City Council to continuously overlapping 3-year terms, and 2 trustees appointed by the Hamilton County Court of Common Pleas to simultaneous 7-year terms - and a mandatory Annual Report of its status and operations to those authoritative bodies.
