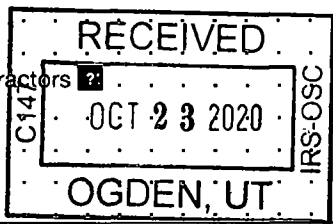

One of the concerts was a Sunday matinee which allowed older patrons to attend. An April 2020 concert was cancelled due to the corona virus. The Chorus has received grants from the Ill Arts Council and the Naperville Special Events committee for many years which allowed the Chorus to either extend its reach in the community and/or provide performances that it could not otherwise offer. The Chorus also manages a smaller "outreach" singing group that performs free of charge primarily to Senior Citizen residences. These were cancelled in 2020 due to the corona virus.
