Part I Line 2	Individuals in need of emergency assistance receive an initial screening by agency social workers. The Thrift Shop works with agencies who have been carefully assessed prior to accepting them as authorized Thrift Shop agencies. Agency social workers, after reviewing the needs of the client and reviewing the requirements of the Thrift Shop, make a request on behalf of the client. The Thrift Shop issues payments on behalf of the client to third parties, such as landlords, utility companies, repair shops, etc. Rent payments are not made to individuals acting as a landlord. A committee of the Thrift Shop board assess, on a regular basis, the criteria for giving financial aid. Thrift Shop volunteers review that clients, and those to whom checks are sent, meet the current financial aid criteria. In addition, monthly block grants are made to a number of area social service agencies based on a grant application process. These grants are monitored through presentations made by representatives of the agencies to the membership of the Thrift Shop. The use of these funds is designated to cover specific small dollar amount requests for clients, which reduces the volume of calls requesting these payments. These grants and the agencies use of the funds are reviewed on a regular basis by the Thrift Shop board.
