Futures has been helping high-need at risk individuals to gain employment, become entrepreneurs, and develop into exemplary leaders who have a positive impact in their underserved community. The CHAMP class' participants were taught the tools of culinary skills, job readiness skills, entrepreneurship, financial literacy, responsible life skills, and on the job training.

In addition, those 15 students who successfully graduate from Paving Great Futures' (PGF) CHAMP classes were provided On- the- job- training (OJT) through its Champion Catering and Flippers Fish & Chicken mobile catering OJT programs. Initially, the OJT trainees received a small stipend and now they are receiving the minimum wage of \$15.00 per hr.

Furthermore, with grants from the San Diego 4th District, SD Mayor, and Chefworks, Paving Great Futures (PGF) was able to purchase equipment and other necessities to launched its mobile catering service, Flippers Fish & Chicken giving its OJT trainees the opportunities to culinary skills in the mobile catering industry. Flippers Fish & Chicken OJT trainees market their skills in Farmer markets, street fairs and other venues.

Finally, Paving Great Futures has received recognition from Chef Works Cares, the charitable initiative from global uniform designer and manufacturer Chef Works, gave its largest grant of \$25,000 to PGF's C.H.A.M.P. It stated that "C.H.A.M.P is poised to become a guiding force for those who may have otherwise felt without a way to economically advance themselves, C.H.A.M.P. paves the way for unlimited financial stability."

individuals to obtaining gainful employment, Paving Great Futures launched a 10 week pilot program, Guiding Empowering Women Entrepreneur Leaders 4 Success (GEWELS). The purpose of the GEWELS program is to provide an understanding of common practices and the administrative needs of a business by offering training in essential workplace skills that are highly valued by entrepreneurs and employers. The program is structured for participants for business or civil service as an entrepreneur or administrative assistant. The GEWELS program is designed for at risk individuals who are striving to improve their overall quality of life, by establishing a consistent source of income and a foundation for growth which is in direct alignment with the mission statement, vision and core competencies of Paving Great Futures (PGF).

The GEWELS program pilot has 4 components: 1) Restorative Practices 2) Office Administration 3) Business Technology 4) Paving Great Futures Core Values. During the 10 weeks some of the topics that our participants learned were Microsoft Office; excel, word and PowerPoint. They learned time management skills and how to conduct themselves in a professional environment. We had several speakers who ranged from business owners to Admin professionals.

One of our biggest achievements was first the restorative practices circle, this component that resonated with every participant in the program. This practice included a mental health check-in to discuss current events, wins and frustrations. The goal of restorative practices was to provide a safe space where women could express their feelings, building a sisterhood among facilitators and the

participants, where there are so many commonalities and shared burdens.

Our second major achievement was the business "Shark Tank" presentation, this was the culminating final project presented by our

participants. The Paving Great Futures executive team was present along with other business owners to pose questions and give the ladies

the space to showcase all that they had learned over the last 10 weeks. Their responses to the possibility of investing in the business

presented, was the ideal exemplification of the participants hard work and knowledge gained from this course. These presentations

allowed the women to develop their business ideas and was a fun and innovative way to measure the success of this pilot program.

When the participants were asked what were some of their biggest lessons learned from the program some of the responses included

"Sisterhood and realizing I am not alone." "Confidence to do great work, budget plan, follow our savings plan, look into LLC, and

The facilitators & group leaders were very professional but yet in a way that the class could relate to."
