The Midland Community School District is the administrative unit currently including these schools. The trustee has always maintained a close and continuing relationship with the school district by exchanging mail and phone calls with the librarian at the school. After the end of each fiscal year on July 31, the librarian submits a report to the trustee detailing how the grant made for the previous year was used. The trustee reviews it, obtains answers to any questions he may have, and then issues a check for the next year grant to the school district. This process has been in place for many years without problems.
