EMPLOYEES ARE REQUIRED TO ENSURE THAT THEIR ACTIVITIES, COMMITMENTS, AND OWNERSHIP INTERESTS OUTSIDE THE SCHOOL DO NOT CREATE ANY ACTUAL OR PERCEIVED CONFLICT OF INTEREST.
