Management reacted swiftly to minimize the impact of the loss of revenue by adjusting staffing levels as well as identifying and closing international study centers. Existing and continuing leases were renegotiated at more favorable terms, and investments were cashed out and reinvested in liquid holdings to ensure availability and more stable balances. In addition, owned properties have been put on the market to sell and generate cash to paydown debt and provide additional liquidity. Management is confident that these actions position CIEE to weather the pandemic, while maintaining the staff and infrastructure to respond to future demand for study abroad and exchange programs and continue its mission of international educational exchange.
