The tax benefits recognized in the financial statements from such position are measured based on the largest benefit that has a greater than 50% likelihood of being realized upon ultimate settlement. The Company did not record any unrecognized tax benefits as of August 31, 2020 and 2019. The Company does not believe it is reasonably possible that its unrecognized tax benefits would materially change in the next twelve months. In the event the Company were to become subject to federal income taxes, the Company's policy would be to recognize interest and penalties related to income taxes as components of interest and penalties expense included within general and administrative expenses in the statements of comprehensive income. As of August 31, 2020 and 2019, the Company did not record any interest or penalties associated with unrecognized tax benefits.
