Schedule L, Part II:	In the Foundation's tax year ending December 31, 2018, David W. Suitor and Linda McGorrill Suitor, who are both Trustees on the Foundation's Board, sold to the Foundation real estate located in Raymond, Maine, on which the camp is operated. As part of this transaction, the Foundation originally agreed to pay a total of \$175,000 (\$8,333 per month for the first year and then \$6,250 thereafter) to the Suitors for consulting and management fees related to the operation of the property. However, the COVID-19 Pandemic forced the Foundation to close its summer camp for the 2020 season. The Suitors agreed to continue their consulting services into the 2021 camp season and fiscal year, with no change to the originally agreed upon fee. As of August 31, 2020, there is a remaining balance due of \$25,000; The final payment, as currently planned, is scheduled for August, 2021. The Suitors were issued a 1099-Misc for the fees paid to them during the 2019 calendar year, and they will receive an additional 1099-MISC for payments received during the 2020 calendar year.
