When COVID-19 hit in the spring of FY20 the power of relationships became evident in our response. As a national network we listened to families impacted by the pandemic and several needs emerged, including food insecurity, insufficient access to books for summer reading, and a lack of opportunities for social-emotional skills. Through affiliated chapters in Central Texas, Indiana, North Texas, Oklahoma, South Texas Rio, Tennessee, North Georgia and Washington DC 3,965 children and youth received food, educational supplies, and virtual summer camp 69,570 meals and food supplies were provided to children and families and 1,298 volunteers distributed meals and provided virtual reading support for children. 90 of parents agreed their children benefitted from summer reading activities.
