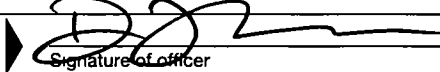
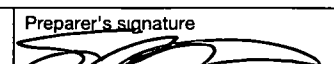

During this sixth year of ministry to the medical needs of the poor in the area of Bahir Dar, the GAMBY Medical Mission has provided surgical treatment and follow-up care for women afflicted the UVP or "Fallen Womb" and has funded cataract and goiter surgery for men and women. Joshua's Way also financially assists the ministry of the Beza Church in Addis Ababa, Ethiopia.
