Access Denver, Impact Denver, Leadership Alumni Network, Leadership Denver, Civic DNA, cDNA Fellows, B:Civic, and Prosper CO are designed to prepare and connect leaders from the business and civic communities to strengthen Colorado's future. Access Denver exposes senior-level Denver executives to the influential people and critical issues of the Denver area, providing an exclusive two-day introduction to the city's business and community landscape. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$115,500 and expenses of \$66,021 for a program net of \$49,479. Impact Denver builds confidence and leadership skills for young professionals while introducing them to topics of significance to the region. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenue of \$281,100 and expenses of \$144,543 for a program net of \$136,557. Leadership Alumni Network ties together over 5,000 alumni of the Leadership Foundation's programs, who represent the Denver Metro region's business, civic, and community leaders. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenue of \$15,240 and expenses of \$79,956 for a program loss of (\$64,716). Leadership Denver is an 11-month program for active leaders focused on assuming civic leadership roles in the Denver Metro community. Leadership Denver is a balance of in-depth issues seminars, retreats, and a group community service project. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$303,679 and expenses of \$186,476 for a program net of \$117,203. Civic DNA represents inclusivity, collaboration, shared vision, and responsibility for today's leaders in Colorado. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$0 and expenses of \$28,114 for a program loss of (\$28,114). Civic DNA Fellows helps leaders with a deep commitment to Colorado to further develop their leadership skills so they can increase their business and civic impact. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$120,411 and expenses of \$130,768 for a program net loss of (\$10,357). B:Civic provides companies of all types and sizes the information, insight and a network to learn more about how to be civic-minded while meeting business goals. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$201,507 and expenses of \$115,826 for a program net of \$85,681. Prosper Colorado is a nonpartisan research and communications project that works to identify the barriers preventing Coloradans from more fully accessing this economy, and pinpoint key strategies to ensure all Coloradans benefit from the state's economic success. Inclusive of contributions made to the program in fiscal year 2020, this program generated total revenues of \$87,800 and expenses of \$189,513 for a program loss of (\$101,713). Community partnerships program expenses totaled \$59,886. Other program expenses totaled \$32,156 during 2020.
