Haven of Hope - Property was given to the Greater Artesia Foundation with the intent to have it ultimately given to the Haven of Hope once the new organization was established. Several companies were engaged to get the appraisal of the property as well as several surveys of the land. Property insurance was obtained in August 2020. Once that occurred, the property was transferred to Haven of Hope allowing the property to be improved for their purposes.

1st Street Project - This project is maintained by Artesia MainStreet, Inc. HollyFrontier gave their donation for work being done on First Street in Artesia, New Mexico to Greater Artesia Foundation and then it was passed on to Artesia MainStreet, Inc. These funds will be used to beautify the First Street project by planting trees along First Street in Artesia.

Form 990, Part III, Line 4c:

Ride for Bikes - 613 bicycles were awarded to the children of Southeastern New Mexico. The bikes were given to the kindergarteners attending public schools in Tatum, Lovington and Artesia, New Mexico. Bikes were purchased using funds donated by companies and individuals and were assembled and delivered by over 250 volunteers across the three towns. Ride for Bikes also provides scholarships to SENM high school graduates that have faced and overcome a challenge in their lives. The scholarship can be used for college or a trade school. Recipients are chosen by a five member volunteer committee that reviews essays submitted by applying seniors. The committee makes their decision based solely on the challenge of the student and the resilience displayed by the applying student to move forward. The scholarship is renewable for up to eight semesters, dependent on grades and attendance. This year, only one new scholarship winner was chosen. No fund raisers were held this year due to the COVID 19 restrictions put forth statewide.

MEMORIAL SCHOLARSHIPS - GAF administers the funds for six scholarship programs. For fiscal year ended August 31, 2020, 20 southeast New Mexico high school graduates received scholarship payments from these funds, including 15 new recipients from the 2020 graduating class. Each scholarship fund has a volunteer review committee that includes members of the school staff. These committees choose the recipients based on pre-set criteria created when the scholarship was funded. Students must provide their acceptance letter and college class schedule initially and their grades for scholarships paid after their first semester. Scholarship checks are paid to and mailed directly to the college/university.

FRIENDS OF THE ARTESIA PUBLIC LIBRARY - A group of approximately 18 philanthropists spearheaded efforts that utilized over 409.5 volunteer hours from September 2019 to March 2020 to provide support to the staff of Artesia Public Library's programs. An estimated 1,386 people were served during this time through the programs and events that Friends helped with, including a Book Discussion Group, book sales, craft times, Halloween Spooktacular, Holiday Shindig, Harry Potter Night, Nerf Wars, and Star Wars Night. Besides their hard work, they raised funds for the Summer Reading Program and helped with expenses for the Family Science Night and other miscellaneous programs. Friends purchased new material for the Story Walk and various supplies for library events which later were cancelled due to COVID 19 restrictions. They are down in their volunteer numbers and the number of people served because the library closed March 13 and has yet to reopen. Therefore, they have been unable to provide any volunteer service from March 13 until now.

This gives these people an opportunity to create and grow their own gardens and help them to provide food for themselves or others within the community. The garden provides a quiet, stress free opportunity for any community member to enjoy. With the recent addition of a commercial grade greenhouse a year round opportunity now exists. The completion of this phase of the garden should be seen in the neighborhood by next year. Many neighborhood residents, schools and local clubs or organizations take advantage of the garden. It is quickly becoming a place for any person with a desire to create a place of beauty to let their imagination go wild. The garden has, and continues to be, funded by both public and private funding and well as with in-kind services and materials.

PACKS OF LOVE - Packs provides sacks of easy to prepare foods weekly on Fridays to school kids whose only meals are those provided at school.
