Explanation: After the organization went through a number of less-than-smooth organizational changes, I accepted sole responsibility for preparing FISH / RHAFT, Inc.'s tax returns in Fall 2019 at which time I fully expected to file for year-ending 2020 well before the January 15, 2021 deadline. However, my significant additional responsibilities managing during the COVID-19 pandemic exacerbated my unresolved concussion symptoms and untreated balance/sensation of movement issues caused by a serious car accident on May 14, 2018. Our FISH transportation program (for which I am also the Coordinator) remained fully operational, when most (if not all) of Monroe County's similar agencies closed, with new/evolving guidelines and support which allowed us to still kept our volunteers and clients safe. Our clients were grateful to be able to continue taking care of their health. We were proud to be able to help them in a way that still resulted in none of our active volunteers and clients contracting the virus! Unfortunately, as the year progressed, my own health issues created more and more challenges for me; by the end of 2020 I had 3 - 5 evaluation and/or treatment appointments per week. It has all been distracting and most distressing. I have had to make a lot of adjustments in what I can do for the organization. My work ethic has told me these are unacceptable "excuses" while my trying to "pull myself up by my bootstraps" and "muscle through" has only made the situation worse. As of May 19, 2021 and June 2, 2021, a few new-to-me medical professionals have finally shed more light on the potential problem(s). Tests are still underway, but I am hoping that with perceptive insight on their part will come improved health for me. I have managed to work through understanding our tax implications and requirements, as well as to navigate through the new-to-us electronic filing system. Even if my medical issues are not fully resolved, I hope I will be able to submit next year's 990-EZ ON TIME.

Explanation: Or, at a minimum, I feel confident I will be able to guide another volunteer through the process to do so. My greatest hope, at this point, is that the IRS will accept this reasonable cause and not penalize our small charitable organization for my human frailties. All our communities' donated funds can then be put to extremely good use serving the Rush-Henrietta residents' in need of transportation and/or emergency food help.
