As part of this reorganization, NHHEAF made the following changes to their bylaws: 1. NHHELCO became the sole member of NHHEAF with all powers of the corporation. Under the previous bylaws the Board Of Trustees of NHHEAF exercised all control and authority. 2. The number of Trustees was increased from a minimum of three (3) to not less than five (5) and no more than seven (7). The sole member will nominate and elect two (2) trustees, the Corporation's President/CEO will serve as an ex officio trustee with full voting rights, and the remaining trustees will be nominated by the Governance Committee of the Board of Trustees. 3. The previous bylaws gave the Governor of New Hampshire an ex officio seat on the Board. The revised bylaws removed this provision. 4. The previous bylaws limited trustees to four (4) three-year terms. The revised bylaws limit trustees to no more than three (3) three-year terms. 5. The previous bylaws required the board to meet semi-annually. The revised bylaws require meetings every two (2) months. 6. The previous bylaws gave officers three-year terms and limited officers to no more than two (2) three-year terms. The revised bylaws require officers to be elected annually, and limit them to no more than three (3) consecutive one year terms.

The purpose of the report was to ensure the Board meet its fiduciary responsibilities as it relates to determining a reasonable market rate of compensation for the position of President and CEO. The report utilized multiple data sources to ensure a robust market assessment and to establish a rebuttable presumption of reasonableness for each member of the authorized body.
