HOUSING (PROSPECT FOREST)CAPSTONE PROVIDES NINE AFFORDABLE HOUSING UNITS IN TWO BUILDINGS (HUD SECTION 8) IN RANDOLPH, VERMONT CALLED PROSPECT FOREST HOMES. THIS GROUP OF FUNDS HOLDS THE PROPERTY, PLANT AND EQUIPMENT USED TO PROVIDE THESE HOUSING UNITS.FAMILY AND COMMUNITY SUPPORT SERVICES (FCSS)OUR FAMILY AND COMMUNITY SUPPORT SERVICES PROVIDES CRISIS ASSISTANCE TO PEOPLE IN NEED OF HOUSING, UTILITIES, AND HOME HEATING FUEL. FCSS PROVIDES 24/7 COVERAGE DURING THE WINTER SEASON TO ENSURE A LACK OF FUEL DOES NOT CREATE UNSAFE HOME CONDITIONS FOR LOW INCOME VERMONTERS. THIS YEAR, OUR COVID RELATED HOUSING SERVICES WERE CRITICAL TO KEEP OUR HOMELESS NEIGHBORS SAFELY SUPPORTED IN TEMPORARY SHELTER. CAPSTONE STAFF PROVIDES SUPPORT SERVICES FOR HOMELESS ADULTS AND FAMILIES HOUSED IN TEMPORARY SITES SUCH AS LOCAL MOTELS. WE FIND HOUSING, VOUCHERS AND RENTAL ASSISTANCE FOR GUESTS. AFTER HOUSING, CCA STAFF PROVIDES ONGOING SUPPORT CONNECTIONS TO HELP PEOPLE STAY HOUSED SUCCESSFULLY.WORKFORCE DEVELOPMENT (CKA)CAPSTONE'S COMMUNITY KITCHEN ACADEMY (CKA) OFFERS LOW INCOME VERMONTERS TRAINING FOR A CULINARY CAREER. STUDENTS ATTEND A 12 WEEK COURSE TO LEARN BASIC CULINARY SKILLS, FOOD SERVICE AND SAFETY, AND GENERAL JOB SKILLS. DESPITE THE PANDEMIC, 22 PEOPLE GRADUATED FROM CKA, 16 STUDENTS GOT JOBS AND 8 EARNED 9 COLLEGE CREDITS. TRANSPORTATIONOUR TRANSPORTATION AND CLIMATE PROGRAMS EXPANDED CONSIDERABLY THIS YEAR IN NEW AND EXCITING DIRECTIONS. WE'VE SUCCESSFULLY SECURED SEED FUNDING FOR A NEW MOBILITY AND EQUITY PROJECT WHICH WILL EXPLORE ACQUIRING A FLEET OF ALL-ELECTRIC VEHICLES TO SERVE AS A CAR SHARE/ COOP, AS WELL AS A RIDE HAILING SERVICE FOR DISADVANTAGED COMMUNITY MEMBERS. OUR NEW MILEAGE SMART PROGRAM PROVIDES GRANTS OF UP TO \$5,000 FOR COMMUNITY RESIDENTS TO SWITCH TO HIGH EFFICIENCY CARS. OTHER ACCOMPLISHMENTSCAPSTONE LED AN INCIDENT COMMAND CENTER EFFORT AT THE HEIGHT OF THE PANDEMIC TO BUILD COLLABORATIVE EFFORTS TO BOLSTER COMMUNITY HEALTH AND SAFETY EFFORTS.
