PARTICIPANTS SHARE FOOD AND DISCUSS FINANCING AND OTHER IMPORTANT INFORMATION IMPACTING THE NEW AMERICAN COMMUNITY. THE VOICES AGAINST VIOLENCE PROGRAM, BASED IN FRANKLIN COUNTY, OPERATES AN ACTIVE EMERGENCY HOTLINE, AND PROVIDED SUPPORT, SAFETY AND ADVOCACY TO ADULTS AND CHILDREN EXPERIENCING DOMESTIC VIOLENCE. VOICES AGAINST VIOLENCE SERVED 513 VICTIMS/SURVIVORS AND 68 CHILDREN AND RECEIVED 1633 HOTLINE CALLS. FAMILIES WITH CHILDREN WERE ALSO SERVED THROUGH A TRANSITIONAL HOUSING PROJECT AND SUPERVISED VISITATION WAS OFFERED TO FAMILIES WITH CHILDREN THROUGH THE ALL ABOUT KIDS PROGRAM. VERMONT TENANTS OFFERED RENTAL COUNSELING SERVICES TO 877 PARTICIPANTS, PARTICULARLY THROUGH ITS HOTLINE. THE PROGRAM ALSO CONDUCTED 96 RENTER EDUCATION CLASSES THROUGH RENT RIGHT, SERVING 348 PEOPLE. TENANTS' RIGHTS AND RESPONSIBILITIES WERE EXAMINED IN LIGHT OF COVID-19, AND THE PROGRAM STRATEGIZED HOW TO HELP WITH THE MOST COMMON AND PRESSING HOUSING ISSUES DESCRIBED IN HOTLINE CALLS. SHORT VIDEOS WERE PRODUCED TO HELP PEOPLE UNDERSTAND THEIR OPTIONS AND THESE WERE INTERPRETED IN SIX LANGUAGES (ARABIC, MAI-MAI, SOMALI, FRENCH, SWAHILI AND NEPALI) BY CVOEO FINANCIAL FUTURES AMBASSADORS. MOBILE HOME PROGRAM (MHP) GOALS ARE TO IMPROVE AND STRENGTHEN RELATIONSHIPS BETWEEN MOBILE HOME OWNERS AND THEIR LANDLORDS, EMPOWER RESIDENTS THROUGH COMMUNITY ORGANIZING AND PROMOTE THE AFFORDABILITY OF MOBILE HOMES. THE MHP HELPS PROMOTE LEADERSHIP AND PROGRAM DEVELOPMENT, ASSIST RESIDENTS ON PARK SALES, CLOSURES AND RENT INCREASES AS WELL ON INFRASTRUCTURE AND HEALTH AND SAFETY ISSUES. IN A TYPICAL YEAR, THE MHP WORKS INTENSIVELY WITH COOPERATIVE PARKS AND WITH SEVERAL PRIVATELY OWNED PARK RESIDENTS TO EXPLORE COOPERATIVE OWNERSHIP. BECAUSE OF THE CORONAVIRUS PANDEMIC, SOME OF THESE ACTIVITIES WERE CUT SHORT OR CANCELLED AS THEY ARE NORMALLY CONDUCTED IN-PERSON. HOWEVER, CVOEO MHP SERVED 81 INDIVIDUALS AND ASSISTED IN THREE PARKS. THE PROGRAM ALSO CONDUCTED A COVID-19 OUTREACH EFFORT IN MARCH AND APRIL, AND CONTACTED CURRENT AND FORMER HOTLINE SERVICE RECIPIENTS, USING A 5-YEAR PERIOD CONTACT LIST. THE EFFORT PROVIDED INSIGHT ON THE IMPACT OF COVID-19 ON MHP RESIDENTS AND MAY INFORM DESIGN OF A RECOVERY PLAN. AS PART OF CVOEO'S STATEWIDE HOUSING ADVOCACY PROGRAMS, THE FAIR HOUSING PROJECT (FHP) PROVIDES PUBLIC ADVOCACY, REFERRALS, EDUCATION, AND OUTREACH. FHP PROVIDED FAIR HOUSING TRAININGS TO OVER 350 LOCAL OFFICIALS AND HOUSING AND SERVICE PROVIDERS. THEIR SERVICES OFFER INFORMATION REGARDING STATE AND FEDERAL FAIR HOUSING LAW AND THE VARIOUS WAYS IN WHICH MUNICIPALITIES CAN INCREASE AFFORDABLE AND STABLE HOUSING OPPORTUNITIES IN COMMUNITIES THAT ARE WELCOMING, INCLUSIVE AND DIVERSE. EDUCATION AND OUTREACH ACTIVITIES TARGET HOUSING AND SERVICE PROVIDERS, MUNICIPAL OFFICIALS, AND VULNERABLE POPULATIONS.

THE FHP PROVIDES SUPPORT FOR LOCAL HOUSING COMMITTEES WITH THE GOAL OF AFFIRMATIVELY PROMOTING FAIR HOUSING VIA ZONING, PLANNING, AND HOUSING DEVELOPMENT PERMITTING REFORMS. THE FHP MAINTAINS A STRONG SOCIAL MEDIA PRESENCE AND COORDINATES CREATIVE, COMMUNITY-BASED "APRIL IS FAIR HOUSING MONTH" ACTIVITIES AND THE STATEWIDE AWARENESS CAMPAIGN "THRIVING COMMUNITIES-BUILDING A VIBRANT, INCLUSIVE VERMONT," WHICH IS A PARTNERSHIP OF HOUSING AND PLANNING ORGANIZATIONS, THE VERMONT DEPARTMENT OF HOUSING AND COMMUNITY DEVELOPMENT, THE VERMONT HUMAN RIGHTS COMMISSION, AND OTHERS. CHILDREN'S INTEGRATED SERVICES OFFERS EARLY INTERVENTION, FAMILY SUPPORT, AND PREVENTION SERVICES THAT HELP ENSURE THE HEALTHY DEVELOPMENT AND WELL-BEING OF CHILDREN, PRE-BIRTH TO AGE 5. SERVICES ARE AVAILABLE AT LOW OR NO COST TO FAMILIES. THE CIS COORDINATOR PROVIDES LEADERSHIP TO THE REGIONAL CIS SYSTEM OF CARE IN ALL ASPECTS OF SYSTEMS DEVELOPMENT, SERVICE DELIVERY, PROFESSIONAL DEVELOPMENT, FINANCING, DATA COLLECTION AND EVALUATION FOR THE CIS ARRAY OF SERVICES, WITH THE GOAL OF SUPPORTING FAMILIES IN ACCESSING NEEDED SERVICES IN A COORDINATED AND INTEGRATED MANNER. CVOEO IS ALSO OPERATING THE STATE'S LARGEST EMERGENCY HOUSING PROGRAM AT THE HOLIDAY INN IN SOUTH BURLINGTON, VERMONT. SINCE APRIL CVOEO HAS HOUSED OVER 280 PEOPLE AND EXPECTS TO HOUSE CLOSE TO 350 BY THE TIME THE EMERGENCY HOUSING PROGRAM CLOSES IN JUNE, 2021. THE NIGHT CENSUS AT THE EMERGENCY HOUSING PROGRAM HAS RANGED FROM 115 PEOPLE TO 154 PEOPLE. CVOEO PROVIDES EMERGENCY SHELTER, THREE MEALS A DAY, ASSISTANCE WITH STATE BENEFITS AND AN ARRAY OF WRAP AROUND SERVICES INCLUDING ACCESS TO MENTAL HEALTH AND SUBSTANCE USE CARE AND TREATMENT, MEDICAL CARE AND A RANGE OF HOUSING SUPPORTS INCLUDING ACCESS TO HOUSING VOUCHERS FOR SUBSIDIZED HOUSING. THE CVOEO HOUSING TEAM IS ALSO ADMINISTERING STATE WIDE HOUSING VOUCHERS FOR THE STATE OF VERMONT AND WILL HAVE ADMINISTERED APPROXIMATELY 360 HOUSING VOUCHERS BY THE END OF MARCH 2021. THE CVOEO COMMUNITY ACTION TEAMS ARE ADMINISTERING RAPID REHOUSING INITIATIVE FUNDS IN THE FOUR COUNTIES. THESE FUNDS ARE FOR A WIDE RANGE OF HOUSING SUPPORTS.
