Through the development and administration of its philanthropic activities, Rhode Island Hospital Foundation (RIHF) is able to transfer funds raised to Rhode Island Hospital (RIH) to support its mission and purposes, which in turn benefits the Rhode Island community. Most notably, RIHF provides philanthropic support to various programs at Hasbro Children's Hospital (HCH), the pediatric division of RIH. In fiscal year 2020, the Foundation transferred the following to various HCH programs and capital projects: \$8,625,228 from the "Every Child, Every Day Campaign", to date a campaign that has raised almost \$35 million since it began three years ago to modernize HCH and grow essential programs and research endeavors vital to children and their families. During fiscal year 2020, RIHF made transfers of \$1,212,926 to support research related to the investigation of the role of epigenetics in adult malignant glioma at RIH. Other significant philanthropic transfers to RIH were as follows: (1) \$703,734 to provide resources to support critical components necessary to create an environment to treat and unravel mysteries of the brain and nervous system; (2) \$520,660 to RIH's Emergency Preparedness Fund, for the general support of COVID-19 patient care; (3) \$278,000 to support upgrades, equipment, maintenance, supplies, staffing, and other operating needs of RIH's Samuels Sinclair Dental Center; (4) \$215,845 to support treatment of the poor/indigent; and (5) \$201,302 to be used within the field of Brain Science Research at RIH, including support of the Brain Tissue Resource Center and the Norman Prince Neurosciences Institute.

Other significant temporarily restricted funds of RIHF sustain clinical shared chairs with The Warren Alpert Medical School of Brown University in cardiothoracic surgery, orthopedics, urology, emergency medicine, and oncology. RIHF's unrestricted endowment is available to be used for various needs of RIH as determined by RIHF's Board and to partially defray RIHF's fundraising expenses, primarily incurred for services purchased from Lifespan Corporation. |

CMN's purposes are fundraising for the benefit of sick and injured children and youth, generating awareness programs concerning the health care needs of children and the institutions and people who care for them, and generating educational programs to promote good health care practices for children and youth. Through RIHF's membership in the CMN, RIHF receives a portion of the funds raised through CMN's fundraising efforts. On a quarterly basis, CMN withholds a portion of these proceeds as a fundraising fee and the remaining amount of fundraising proceeds is distributed to RIHF. In addition to the fundraising fee withheld from proceeds raised, RIHF pays an annual membership fee to CMN. The annual membership fee and quarterly variable collection fees paid by RIHF to CMN during the fiscal year ended September 30, 2020 amounted to \$128,988. RIHF's quarterly payments to CMN also include reimbursement to CMN for various other fundraising expenses such as fundraising campaign kits, public awareness materials, registration fees, and fees associated with collecting proceeds via credit card. RIHF receives invoices for these expenses and reimburses CMN for its incurred costs. |

| Grantmaker's Description of How Grants are Used | RIHF engages in philanthropic activities to support the mission and purposes of Rhode Island Hospital (RIH), a related 501(c)(3) organization (which includes its pediatric division, Hasbro Children's Hospital). During the fiscal year ended September 30, 2020, RIHF made temporarily restricted net asset transfers to RIH amounting to \$14,870,465 to be spent by RIH in support of certain building and equipment additions or specified clinical programs. A master database of RIH's temporarily restricted funds is maintained as the primary source for identifying each fund's restriction, the availability of the current balance, and the authorized personnel for the respective fund. The database contains the fund's name, primary reporting department, most recent month end balance, fund purpose/restriction, and the management responsible for the fund. Expenditures (purchase requisitions, work order requisitions, check requests, and employee reimbursements) from RIH's temporarily restricted funds must be presented to the Lifespan Finance Department for approval prior to processing. Each request is reviewed to ensure the availability of funds and that the expense/purchase is both in conformity with the fund's restriction and approved by the required levels of authorized personnel referenced in the database. RIHF and Brown University (Brown) have several agreements pursuant to which each entity maintains endowment funds representing 50% of certain endowment gifts which support various clinical shared chairs. Each agreement specifies a spending rate which is applied to the trailing three-year average fair value of the applicable endowment funds to arrive at an amount used to support the named professorships. Payments distributing these amounts, which are made by RIHF to Brown on a quarterly basis, totaled \$427,242 in the fiscal year ended September 30, 2020. Under the terms of the agreements, Brown is required to provide an accounting to RIHF sixty days following the anniversary of each agreement. |
