St. Mary's Basic School in Montego Bay region, African Martyrs and Marcus Garvey schools serve pre-school children and received support grants. Scholarships for tuition, books, supplies, uniforms,lunch programs and COVID-19 supplies/technology were funded for 852 students at St. Pius X., St. Peter Claver, Immaculate Conception, St. Benedict's, St. Theresa, King Weston Primary and Montego Bay Diocese. The DuPont school received funding for a Parent Literacy program. A summer program was funded at Holy Trinity. All these services to the poorest of the poor will inspire students to improve their quality of life and avoid inner city poverty, crime and drug problems in the future.

Food & Goods From time to time we receive clothing, books, dental supplies and household goods that our volunteers label and catalog, then ship to Jamaica. We collected a total of 77 boxes this year. We provided grants to the Love in Action soup kitchen in the Montego Bay region where an estimated 70 poor persons are served each day, 4 days a week, and food packages are delivered on Thursdays to over 150 poor in the inner city. Several grants were made to provide food during the COVID-19 pandemic due to the unprecedented unemployment crisis in Jamaica.

Housing & Community BuildingJOP funded the building of homes for needy families and the elderly, who previously lived in make-shift tents, rusty sheets of tin and cardboard shelters. Ten housing units were built, each with a concrete foundation, sturdy roof, walls, sanitation facilities and a door. Over the past 14 years, 535 homes have been built for the poor.

This past year, 1 mission trip was completed with 12 volunteer dental professionals. 967 dental patients were seen and provided with services including cleanings, extractions, fillings, fluoride varnish and many other treatments or referrals. An additional mission trip to Seaford Town served 101 patients. COVID-19 forced the cancellation of several other mission trips. Amounts reported exclude in-kind dental care professional services valued at \$60,368. OTHER PROGRAM SERVICES 5: Vision CareIn two mission trips this past fiscal year, optical exams were completed on 252 patients, 211 pair of prescription eyeglasses were delivered. One mission was to the diocese of Montego Bay. In addition, many patients were diagnosed with needing cataract or other eye surgery and or treated for glaucoma. Amounts reported exclude in-kind vision care professional services valued at \$21,440. Over the past 22 years, 61 optical trips have been made, seeing approximately 14,216 patients for eye exams and delivering over 10,855 pair of eyeglasses. The COVID-19 pandemic forced cancellation of additional eye care and surgery mission trips. OTHER PROGRAM SERVICES 6: MedicalTwo mission trips to Seaford Town's medical clinic at Sacred Heart served 227 patients. Jamaica Outreach Program supplies the clinic with medicine dispensed to patients free of charge. The Good Shepherd Foundation clinic in Montego Bay received a grant as well. COVID-19 required the cancellation of additional mission trips, but the team is eagerly awaiting the time when they can return to mission work. Reported amounts exclude non-cash medical services valued at \$26,560. OTHER PROGRAM SERVICES 7: Mission TripsSix mission trips to Jamaica were made this year, by 34 volunteers. Each major trip is typically 4 to 5 days and volunteers pay for their own airfare, local transportation, meals and lodging (except for nurses, opticians, dental hygienists and assistants who received travel subsidies). Expenses totaling \$567 are reported here and reimbursement from volunteers is reported as Other Revenue. Activities focus on medical, dental or vision care. OTHER PROGRAM SERVICES 8: Other Program ServicesThe poor in the community of Immaculate Conception Church and missions have recently been supported by JOP. The statistics in our Education, Medical, Dental and Optical programs include support to the poor in this community, the balance of grants for maintenance support is reported here. OTHER PROGRAM SERVICES 9: St. Pius X CompoundOver the past 23 years, JOP has constructed medical facilities, a food pantry and improved other facilities on the grounds of St. Pius X Church. The walled compound is a safe haven for the poor in Kingston's inner city. JOP support the ongoing maintenance, repairs, utilities, security and administrative costs for these facilities.
