Harrison Alexander Trust is a Testamentary Trust. In 1984, the New Hampshire Rockingham County Superior Court ruled that the Alexander Eastman Foundation, EIN# 02-0222124, of Derry, New Hampshire should receive the annual income. In 2002, The New Hampshire Rockingham County Superior Court ruled that all grants required by the Internal Revenue Code in order to avoid excise tax on undistributed income must be distributed to the Alexander Eastman Foundation. For the year ended 9/30/19, Harrison Alexander Trust approved a grant of \$33,723 to the Alexander Eastman Foundation.
