The Zachary Bowling Pediatric Outpatient Diabetes Education Services at El Paso Childrens Hospital is Recognized by the American Diabetes Association for Quality Diabetes Self-Management Education* and Support. It is the only pediatric outpatient diabetes education services in El Paso and the 350-mile surrounding area that is Recognized by the American Diabetes Association. El Paso Childrens Hospitals Certified Diabetes Educators are Certified Insulin Pump trainers and Certified Continuous Glucose Monitor trainers; they are up-to-date on the newest technology available for children with diabetes. The Pediatric Diabetes Education Services at El Paso Childrens Hospital now hosts an annual Pediatric Diabetes Conference for community healthcare professionals and school nurses.
