Fiscal Sponsorships - As part of our response to the Covid crisis, and reflecting our mission statement of "empowering" members of the LGBTQIA+ community to meet their goals and aspirations, PCSO is the fiscal sponsor of several small and fledgling nonprofit organizations. (See Schedule R for a complete listing and description.) By accepting grants and donations on behalf of these groups, we enable them to qualify for funding and start new programs and services in their communities. By providing oversight and financial management, we help each organization start out on sound footing, enabling them to focus on their mission statements while they are growing and preparing to apply for non-profit status as independent organizations. Funds received in excess of expenses paid for them are 1) held in reserve for the organization, and 2) paid as fiscal sponsorship fees, a small percentage of their income. This covers administrative expenses for PCSO staff to track and report bookkeeping and program statistics. PCSO also maintains separate bank accounts for two disregarded entities that at the present time have no plans to apply for 501(c)(3) status. Funds held in reserve for these organizations / entities total \$11,945.67 as of the end of this short reporting period (9/30/2020).

Pride Festival - This in the past has been our biggest program of the year, and would normally produce a lot of revenue and expenses. However, due to Covid, the festival, which is usually a large public event in downtown Lexington, was cancelled. Most of the booth fees and other revenue had to be refunded. Due to the economic situation, very few vendors elected to donate what would have been their booth fees, though some corporate sponsors volunteered to provide funds to PCSO without the normal publicity of the festival. We are thankful for their support

LinQ Magazine is distributed to area high schools, colleges, libraries, churches, and businesses. 45 bulk drop off locations and individual mailings, printing an average of 550 copies per month for a full year of 12 issues. LinQ can also be read through direct email listserve sign-up or past issues are available online via the website. LinQ Magazine offers articles of interest on important community celebrities; resources available for youth or young adults who need assistance or counseling, or who are looking for a welcoming and accepting religious community; current LGBTQ+ related offerings in film, theater, art and music; as well as discussions about important current events in the wider world.

PCSO is/was the acting "fiscal sponsor" of KCET, New Song, CompanyQ, and Pikeville Pride Festival, handling all donations & expenses for them, and providing oversight and management, as well as bookkeeping and reporting. Funds donated to some above listed organizations are held by PCOS as part of operating funds, and disbursed as needed or requested. PCSO has the authority under the fiscal sponsorship agreements to review and decline to approve requested disbursements, and is the legal owner of all property and equipment obtained by the fiscally sponsored organizations. At the time they receive independent 501c3 status by successfully completing a 1023 application with the IRS, PCSO donates all property and equipment purchased for the supported organizations, as well as disbursing any remaining cash funds to their independent control. PCSO also maintains separate bank accts for some programs as disregarded entities, GSA & The Pride Festival. PCSO provides the same oversight and management for sponsored organizations that have separate bank accounts as for those who do not. Most of these fiscal sponsorships fall well under the \$50,000 threshold for reporting transactions. If any one organization received more than \$50,000 in disbursements during this reporting period, they are listed on Page 3, Section 2, with the total amount of transfers/expenses paid

Fiscally sponsored organizations that fail or dissolve prior to achieving independent 501c3 status will be reported as such on subsequent Schedule R filings (if that should occur). We will provide surviving successful 501c3 applicants with an official letter of release of agency and information needed to file their own 990s by reporting to them all the expenses & disbursements paid by PCSO during their 1st official year.

In 2020, due to Covid cancellations of many activities, programming, and events, there was far less activity than usual for these sponsored organizations. Hopefully things will improve in 2021 and 2022.
