"I Care" Refugee Assistance Program/GIK - Mission Eurasia distributes humanitarian aid (GIK) in Ukraine and throughout Eurasia to provide holistic care for those in need. Each year, our School Without Walls (SWW) leaders, in partnership with local churches and volunteers, reach hundreds of thousands of people for Christ by bringing them desperately needed clothing, food, wheelchairs, and other items. In 2020, Mission Eurasia used our "I Care" Refugee Assistance Program to provide humanitarian aid for approximately 787,000 refugees and other people who are suffering due to the ongoing crisis in eastern Ukraine, the war between Armenia and Azerbaijan, and other crises. In 2020, our SWW leaders distributed 128,980 Gifts of Hope, brightly colored boxes filled with sweets, toys, school and hygiene supplies, warm mittens or socks, and a children's Bible or other Christian literature, during the Christmas season.

More specifically, SWW and NGPLI provide Next Generation leaders and young professionals with biblical wisdom, leadership training, and practical, hands-on ministry experience. In 2019-2020, Mission Eurasia trained 2,195 young leaders from 13 countries in Eurasia and Israel through SWW, and we used NGPLI to equip 14,700 young professionals in Eurasia for ministry in their workplaces and spheres of influence.
