Providing free food and supplies to the needy in our area both on a drive-through basis (open two days a week at our pantry) and via delivery to those unable to pick up. The total value of food and supplies (cleaning/toiletries) provided (estimated per client) includes \$10,001 of items purchased with our cash donations and \$224,326 of in-kind donations from local food banks, retailers, our parishioners, and other church congregations and school groups. The food and supplies were given to 2,293 families. We received no revenue for this activity.

4b (Code:) (Expenses \$ 50,450 including grants of \$) (Revenue \$ 0)

Providing crisis financial assistance to those in need in our area, including payments to avoid utility shut-off or rent eviction; paying for a gas-tank fill-up or bus tokens; paying for medical bills, furniture, or similar needs. This help was provided to 376 families. All funds for this ministry came from donations by our church members or other individuals. We received no revenue for this activity.

4c (Code:) (Expenses \$ 28,633 including grants of \$) (Revenue \$ 0)

Providing new and used clothing, linens, housewares, toys, and furniture to those in need in our area. These items are primarily picked up from our Outreach Center while the food pantry is open, plus some are delivered or provided by special distributions. The total value of these items are estimated on a per-client basis; all of them come from in-kind donations to our center from individuals. These items went to 717 families. We received no revenue for this activity.

Part I Line 2: We are a charitable organization ministering to those in need. All monetary grants and in-kind distributions are made to individuals who indicate financial need - primarily in compliance with attestations of income levels below those required by federal and state food bank programs. Clients must also provide evidence of residence for ongoing help as, per our by-laws, we primarily serve those in our parish area. Monetary grants (crisis financial assistance) are typically provided only to avoid utility shut-off, rent eviction, and similar situations. Any such cash payments are made directly to the utility provider, landlord, or transport or medical provider after verification of need with that provider. We do not give cash or checks to clients, thereby safeguarding that funds are used as intended. Records of our financial and food assistance are maintained each in an on-line system developed for those purposes. These records are updated at each visit by, or to, a client. Our practices track and significantly limit the amount of assistance any one client can receive, as well as limiting the times they can re-apply for further assistance. Therefore no individual client received aid in excess of \$2000 total within the year

Part I Line 19: The number of contributions (column b) is estimated by including 50 deliveries from a local food bank, 36 pick-ups by our volunteers from two food banks, and an observed 600 individual contributions from church and school food drives, individual drop-offs, and other small contributions. The value of these food contributions (column c) is based on the general cost of similar food items at local grocery stores. We calculate the valued amount of food we typically provide to each client family, multiply by the number of families served, and subtract the actual cost of food items we purchase with our cash donations. While the amount of food we give to each family typically includes some 40 items, most of these are recurring staples and perishables, which makes the valuation process relatively consistent. We use a similar process for our holiday food distributions.
