THESE PROJECTS FOCUSED ON POLLINATORS, LAND STEWARDSHIP, AND LANDSCAPE IMPROVEMENTS AND WILL IMPACT UPWARDS OF 250,000 PEOPLE IN REGIONWIDE. OL FORESTRY PROGRAM SUPPORTS THE PLANTING OF TREES WITH COMMUNITY RESIDENTS ON PUBLIC LAND AND EDUCATES RESIDENTS IN THE CARE AND ADVOCACY AROUND THE URBAN FOREST. IN FY 20, 1230 TREEKEEPERS AND COMMUNITY VOLUNTEERS WERE ENGAGED IN TREE PLANTINGS, CONTINUING EDUCATION, AND FIELD WORK TO CARE FOR TREES PLANTED IN PRIOR SEASONS. TREEKEEPERS LEARN HOW TO HELP KEEP TREES GREEN AND GROWING, VOLUNTEERING IN A VARIETY OF SITUATIONS FROM STREET TREE CARE AND TREE PLANTING TO WOODLAND STEWARDSHIP AND ADVOCACY. THEY ARE PASSIONATE AMBASSADORS WHO HELP EDUCATE THEIR NEIGHBORS AS WELL AS THEIR PUBLIC OFFICIALS ABOUT THE IMPORTANCE OF TREES FOR THE GREATER GOOD.
