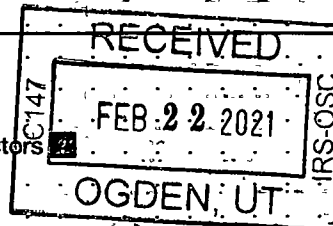

**Part III-line 28 - Southwest Marion Volunteer Fire Department (SWMVFD) is an organization which has contracted to provide fire suppression services, basic medical response and response to motor vehicle accidents to the residents in southwest Marion County. This area of service extends slightly over 100 square miles and serves about 2000 homes and 5000 persons. A County fire protection district supplies resources such as fire stations (four), equipment (five pumpers, two brush trucks and other items such as PPE, etc,) plus operating expenses such as fuel and maintenance to the department. About 15 volunteers provide the manpower to respond to about 100 to 150 incidents per year.**

**Part III-line 33 - Did the organization engage in any significant new activity - Our " Other Income" shown on Schedule A, Part II, Section B-line 9 averaged around \$500 per year for the 4 years preceding tax year 2019. In April 2020, one of our fire stations was destroyed by a tornado. Our County fire protection district would have replaced the station had not the fire department received \$106,726 in unsolicited donations for replacement of the destroyed station.
