THERAPY - THERAPY IS A CRITICAL COMPONENT OF THE HEALTH AND WELL-BEING OF A CHILD WITH A DISABILITY. AT TIMES, VARIETY CHILDREN MAY NEED MORE CONSISTENCY AND INCREASED FREQUENCY TO ADEQUATELY ADDRESS THEIR NEEDS. VARIETY FAMILIES ARE OFTEN UNABLE TO MEET THAT NEED AS IT MAY NOT BE COVERED BY PRIVATE OR PUBLIC INSURANCE. TO HELP CLOSE THE GAP, VARIETY PROVIDES ACCESS TO MEDICALLY PRESCRIBED PHYSICAL, OCCUPATIONAL, EQUINE, AQUATIC AND SPEECH THERAPY. DUE TO THE COVID-19 PANDEMIC, IN MAY 2020, MOST CHILDREN LOST ACCESS TO THERAPY AS CLINICS AND SCHOOLS WERE FORCED TO CLOSE. VARIETY LAUNCHED VIRTUAL THERAPY AS AN ALTERNATIVE OPTION. AS RESOURCES OPEN BACK UP, VARIETY CONTINUES TO PROVIDE ACCESS TO BOTH IN PERSON AND VIRTUAL THERAPY. VARIETY ENABLES CHILDREN TO RECEIVE THE THERAPY NECESSARY FOR THEIR GROWTH WHEN THEY NEED IT. IN FISCAL YEAR 2020 VARIETY PROVIDED 2,229 THERAPY SESSIONS TO 136 CHILDREN. PARENTS REPORTED THAT 100% OF VARIETY CHILDREN RECEIVING THERAPY DEMONSTRATED BELIEF IN THEMSELVES, THEIR ABILITIES, AND THEIR POSSIBILITIES.
